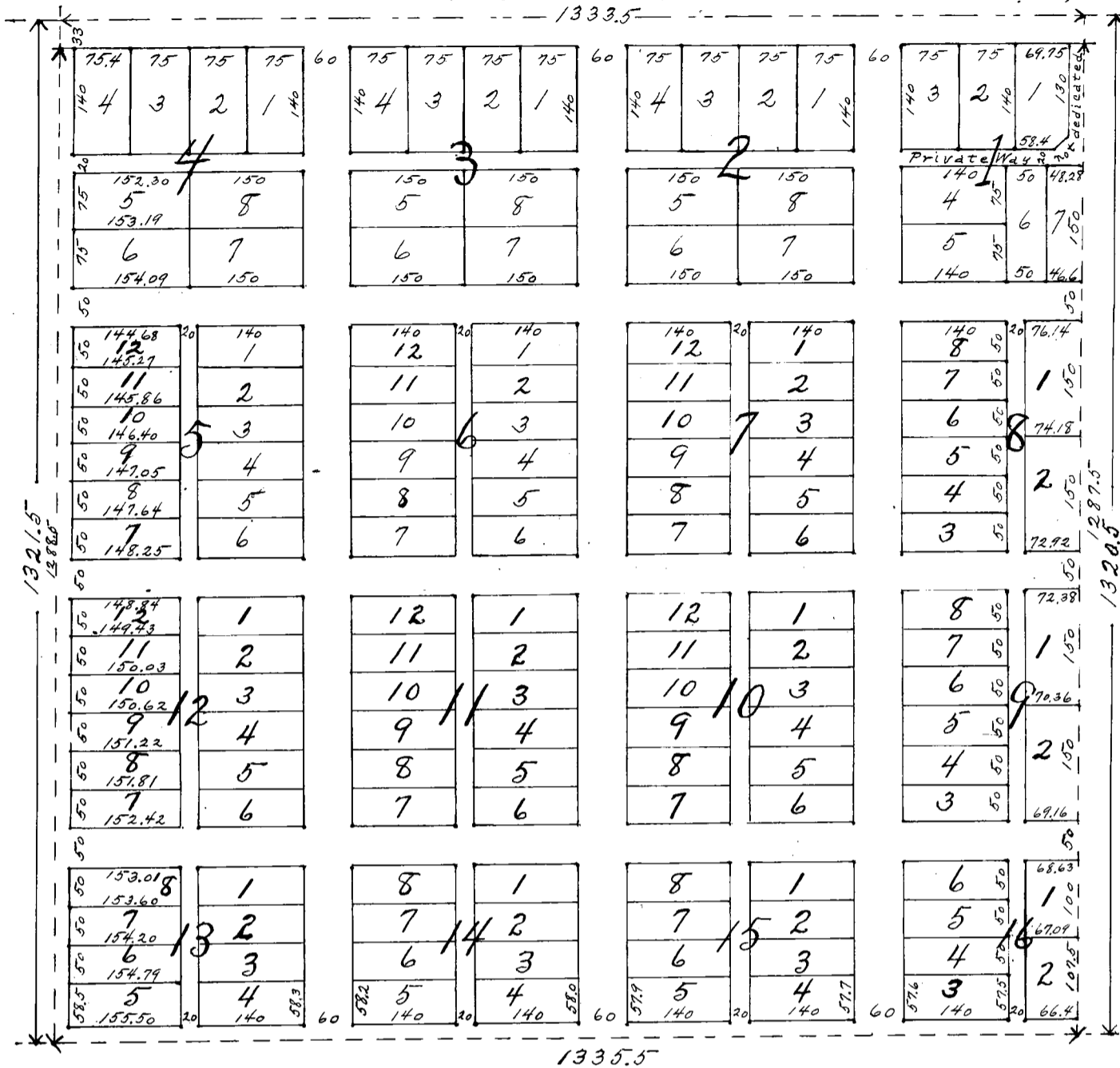

McCoskey do hereby certify that on the 20th day of May, 1910, I completed the Survey of HARVARD PLACE being the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of section 25, T. 22 N., R. 55 W. of the 6th P.M. Neb., described as follows: Beginning at a point 1333.5 feet East and South 33 ft. South of the corner of Sections 23, 24, 25 and 26 said T. & R. thence South (Va. 15° 2' 12885 ft. thence east (Va. 15° 48') 13355 ft. thence North (Va. 15° 9') 12875 ft. to a point 33 ft. South of the $\frac{1}{4}$ Sec. corner between Secs. 24 and 25 said Tp. & R. thence west (Va. 15° 45') 13335 ft. to the place of beginning; that the numbers of the blocks and dimensions of the lots, the widths of the avenues, streets and alleys are as shown in figures on the plat and that the names of the avenues and streets are also as shown on the plat; that pine stakes are driven firmly in the ground at the front corners of each lot.
