

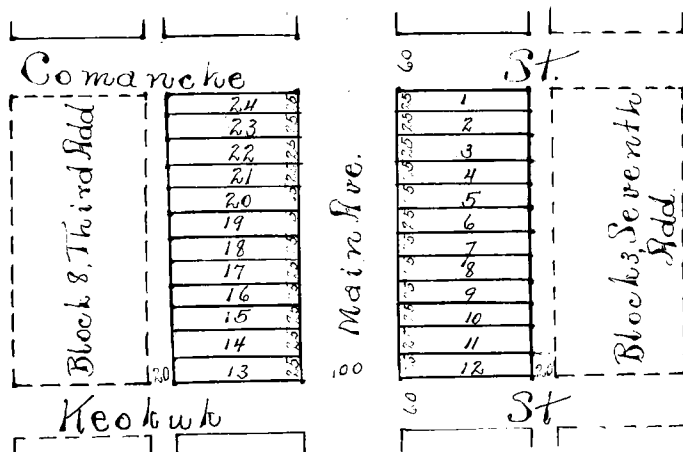

I hereby certify that during the month of February, A. D. 1916, I surveyed Main Street Addition to the Town of Scottsbluff situated in part of the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Sec. 23 T. 22 N. R. 55, W of the 6th Principal Meridian as shown by the annexed plat which is a correct delineation of said survey, drawn to a scale of 200 feet to an inch. The streets and Avenue are extensions of those of the same name in the Original Town and Addition thereto. Burr oak stakes are driven well into the ground at the front corners of each lot. The width of streets, avenues and alleys, and dimensions of lots are indicated in feet and decimals by red figures on the annexed plat. Each lot bears its own number.

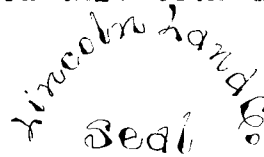

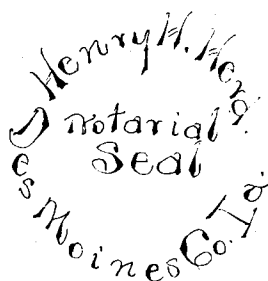
