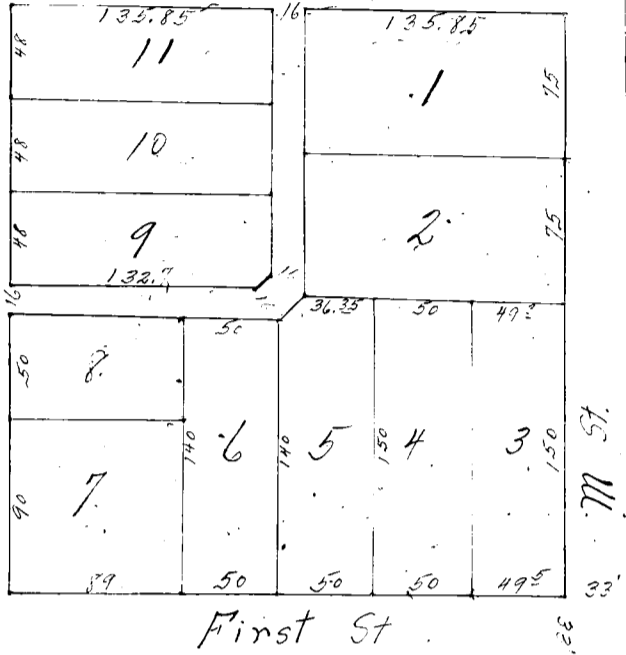

I hereby certify that on  
the 8th day of June, 1917,  
I surveyed Morrill Home  
Addition to Scottsbluff,  
situated on a part of Sec.  
23, T. 22 N., R 55 W. de-  
scribed as follows: be-  
ginning at a point 33'  
North and 33' West of the  
S.E. cor. of Sec. 23, T.22,  
R. 55, thence West 288.5  
feet, thence North 300 feet,  
thence East 287.7 feet,  
thence South 300' feet to  
the point of beginning;  
that the above plat is a  
correct delineation of said  
survey drawn to a scale of  
100 feet to an inch. 2"x2"  
Pine Stakes are driven well  
into the ground at front  
corners of each lot. The  
width of the alley and the  
dimensions of the lots are  
indicated on the plat in  
feet and decimals. Each  
lot bears its own number.

Public Use.
