

FIRST ADDITION TO SCOTTSBLUFF.

SCOTTS BLUFF COUNTY, NEBRASKA.

I heeby Certify that on the 22, day of December, 1904, I surveyed First Addition to Scottsbluff, situated on a part of the E.2, of the S.E. 4, of Sec 23, T. 22, N. R. 55, of the 6th P.M. which is clearly shown by reference to the original town, The Streets in the Addition running East and West, being extensions of those of the same name in the original town, Burr Oak stakes are driven well into the ground at the front corner of each Lot, The annexed Plat is a correct delineation of said Addition, drawn to a Scale of 180 feet to an inch, together with part of Blocks I, 8, 9, 2 and I4. in dotted lines of the viginal town, The Dimension of Lots and width of Streets, avenues and alleys, are indicated in feet, by Red figures on the Plat, Each Lot and Block has its own Number.
