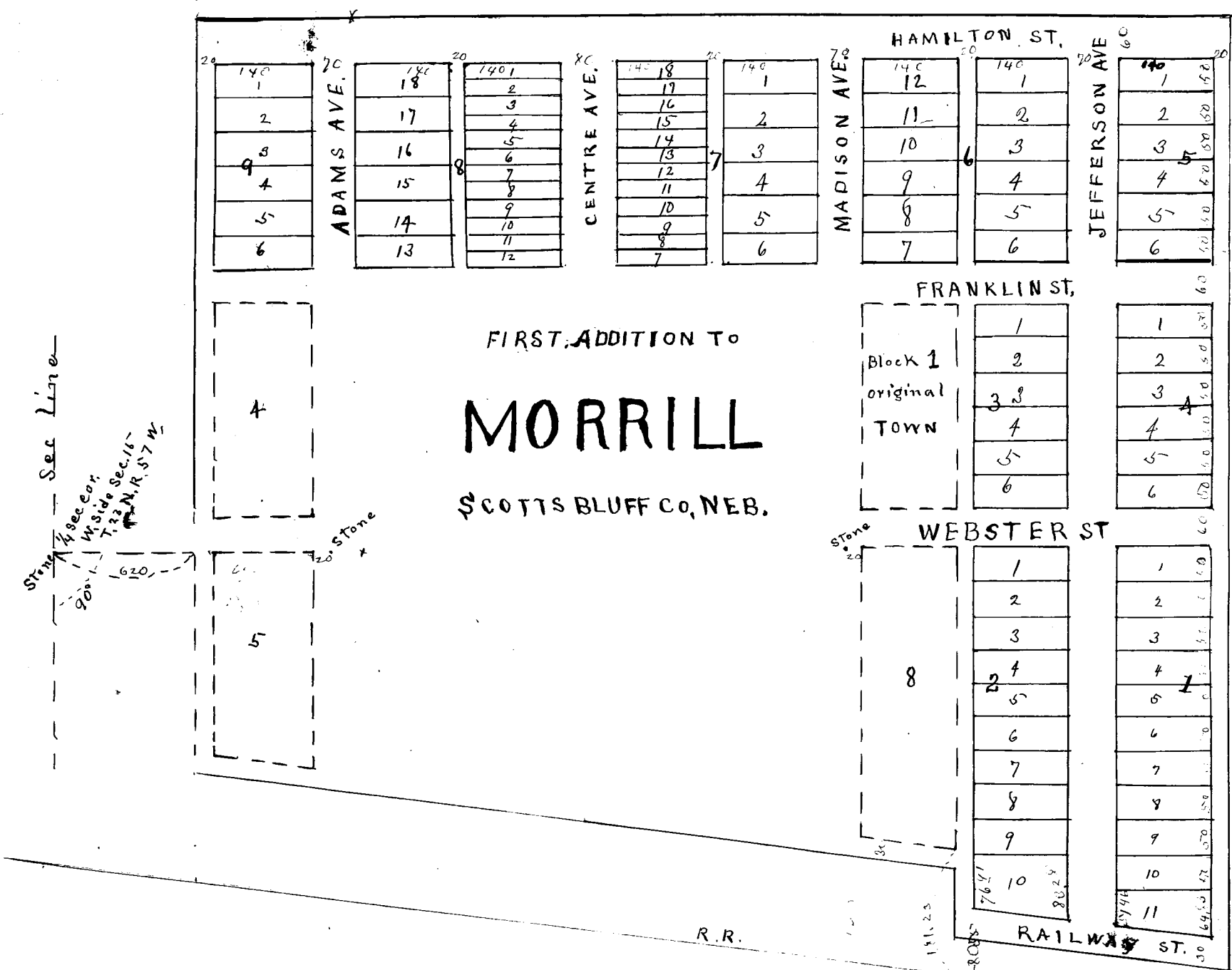


DEED RECORD.

I hereby certify that in the month of Oct. & Nov. 1906 I surveyed First Addition to Morrill situated on a part of the W $\frac{1}{2}$ of Sec. 15 T. 23 N.R. 57 W. as shown by the foregoing plat which is a correct delineation of said survey drawn to a scale of 200 feet to an inch the streets avenues and alleys are extensions of that of same names in the original town and additional ones are parallel with corresponding ones. Burr oak and cedar stakes, intersperced, are driven well into the ground, at the front corners of each lot. The width of streets avenues and alleys and dimensions of lots are indicated by red figures. Each lot and block bears its own number.
