

I HEREBY CERTIFY: That in the month of February 1909, I surveyed the Town of H E N R Y, situated on Lot 4 Section 3 and Lot 1 Section 4 of Township numbered Twenty-three (23) North of Range numbered Fifty eight (58), West of the Sixth principal Meridian, as shown by the foregoing plat which is a correct delineation of said survey drawn to a scale of 200 feet to an inch. The streets, Avenues, and Alleys are laid out parallel with and at right angles to the north boundary of said Section 4, except South Railway Street, which is parallel with the Railroad, 60 Penny Spikes are driven well into the ground at the front corners of each lot, A cement block was found at the Northeast corner of said Section 4 and a three inch cast iron pipe with U. S. Land Office brass cap was found at the Northwest corner of said Section 4.

The width of all streets, Avenues, Alleys and dimensions of lots are indicated in feet and decimals by red figures on the plat. Each lot and block bears its own number.
