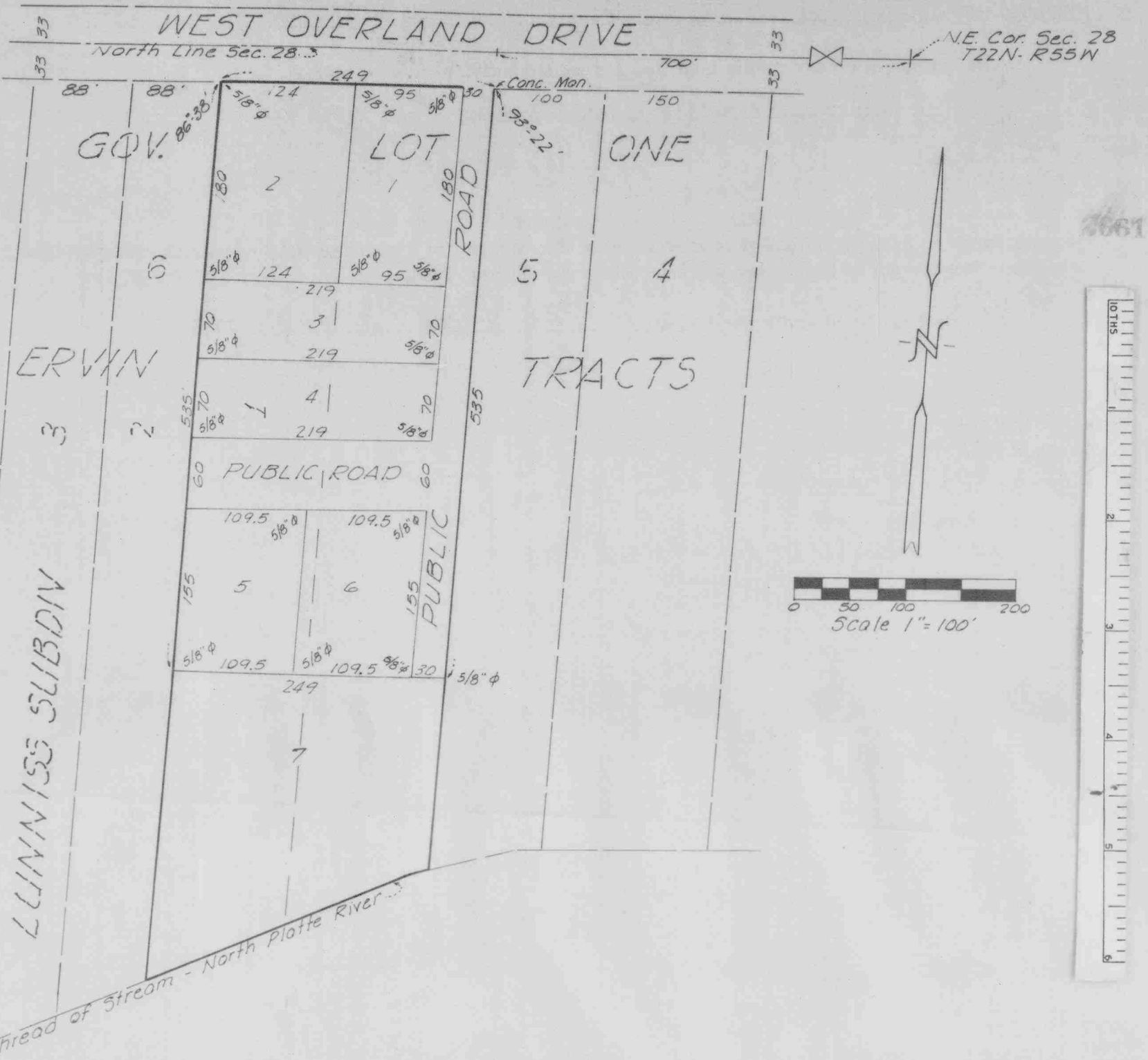


# SCHLICHTEMIERS SUBDIVISION
