

SURVEYOR'S CERTIFICATE

I, E.Y. GRUPE, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have accurately surveyed Lots 1 and 2, Block 1, Rugger Park Addition to the City of Scottsbluff, Nebraska, situated on part of the West Half of the Northeast Quarter ($W\frac{1}{2}NE\frac{1}{4}$), of Section Fourteen (14), Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows:

Beginning at a point 1902.7 feet North of the center of Section 14 and 70 feet East of the North-South center line of that Section; thence North and parallel to the North-South center line, for a distance of 633.3 feet to a point 50 feet South of the center line of the Enterprise Irrigation Canal; thence right a deflection angle of 111 degrees and 17 minutes for a distance of 322 feet; thence left a deflection angle of 21 degrees and 33 minutes for a distance of 243.8 feet; thence left a deflection angle of 7 degrees and 41 minutes for a distance of 211.3 feet; thence right a deflection angle of 26 degrees and 48 minutes for a distance of 190.3 feet, this point being 50 feet South and perpendicular to the centerline of the Enterprise Irrigation Canal; thence right a deflection angle of 71 degrees and 9 minutes in a southerly direction and parallel to the North-South center line of Section 14, for a distance of 480.0 feet; thence right a deflection angle of 89 degrees and 40 minutes for a distance of 933.4 feet to a point 70 feet east of the North-South center line of that Section and the point of beginning, containing 11.3 acres.

The accompanying plat is a correct delineation of said survey drawn to a scale of 100 feet to the inch.

All dimensions are shown in feet and decimals. All block corners are marked with $5/8 \times 36$ " iron rods and all other corners are marked with $5/8 \times 18$ " iron rods. The boundary of this subdivision is marked with a heavy dotted line. The lots are numbered and each lot and block bears its own number.
