


**REPLAT OF LOT ONE (1) BLOCK ONE (1)

SURVEYOR'S CERTIFICATE

I, E.Y. GRUPE, A COMPETENT SURVEYOR OF SCOTTSBLUFF COUNTY, NEBRASKA, HEREBY CERTIFY THAT I HAVE SURVEYED THE REPLAT OF LOT ONE (1), BLOCK ONE (1), WHITEHEAD ADDITION SITUATED IN THE WEST HALF OF THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER ($W\frac{1}{2} NE\frac{1}{4} NE\frac{1}{4}$) OF SECTION TWENTY FIVE (25), TOWNSHIP TWENTY TWO (22) NORTH, RANGE FIFTY FIVE (55) WEST OF THE SIXTH PRINCIPAL MERIDIAN IN SCOTTSBLUFF COUNTY, NEBRASKA; MORE PARTICULARLY DESCRIBED AS FOLLOWS;

BEGINNING AT A POINT ON THE NORTH LINE OF SUCH NORTHEAST QUARTER OF THE NORTHEAST QUARTER ($NE\frac{1}{4} NE\frac{1}{4}$) AND 1335.54 FEET WEST AND 33 FEET SOUTH OF THE NORTHEAST CORNER OF SUCH SECTION TWENTY FIVE (25); THENCE EAST ON SUCH NORTH LINE FOR A DISTANCE OF 277.0 FEET TO THE NORTHWEST CORNER OF LOT TWO (2), BLOCK ONE (1), WHITEHEAD ADDITION THENCE SOUTH ON THE WEST LINE OF SUCH LOT TWO (2) A DISTANCE OF 310.0 FEET; THENCE WEST ON THE WESTERLY EXTENSION OF THE SOUTH LINE OF SUCH LOT TWO (2), A DISTANCE OF 277.0 FEET; THENCE NORTH AND PARALLEL TO THE WEST LINE OF SUCH LOT TWO (2), A DISTANCE OF 310.0 FEET TO THE POINT OF BEGINNING.

THAT THE ACCOMPANYING PLAT IS A CORRECT DELINEATION OF SUCH SURVEY DRAWN TO A SCALE OF 100 FEET TO ONE INCH.

THAT THE CORNERS OF SUCH LOT IS DESIGNATED BY $\frac{5}{8}$ " x 36" IRON RODS DRIVEN WELL INTO THE GROUND.

THAT ALL DIMENSIONS ARE SHOWN IN FEET AND DECIMALS.

THAT THE BOUNDARIES OF THE ADDITION ARE SHOWN ON THIS PLAT IN HEAVY SOLID LINES.



CORPORATION WARRANTY DEED

The grantor, SALEM CONGREGATIONAL CHURCH OF SCOTTSBLUFF, NEBRASKA, a corporation organized and existing under and by virtue of the laws of the State of Nebraska, in consideration of One Dollar (\$1.00) and other valuable considerations, received from grantee, does grant, bargain, sell, convey and confirm unto EASTSIDE CHURCH OF CHRIST, SCOTTSBLUFF, NEBRASKA, herein called the grantee, the following described real property in Scotts Bluff County, Nebraska:

Lot Five (5), Block Two (2), ASSOCIATION HEIGHTS ADDITION to the City of Scottsbluff, Scotts Bluff County, Nebraska, according to the recorded plat thereof, and

The North 3 feet of Tax Lot Ten (10), situated in the Southwest Quarter (SW $\frac{1}{4}$) of Section Twenty-four (24), Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows: Beginning at the Southeast corner of Lot Five (5), Block Two (2), ASSOCIATION HEIGHTS ADDITION to the City of Scottsbluff, Nebraska; thence South along the East line of such Lot 5 extended, a distance of 3 feet; thence West and parallel with the South Line of such Lot 5, a distance of 156 feet to a point on the West line of such Lot 5 extended South; thence North parallel to the East line of such Lot 5, a distance of 3 feet to the Southwest corner of such Lot 5; thence East along the South line of such Lot 5, a distance of 156 feet to the point of beginning,
