

SURVEYOR"S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed Valley Vista, Lots Two through Ten, Block Seven; Lots Two through Ten, Block Four and Lots Seven and Eight, Block Eight, an Addition to the City of Scottsbluff, Nebraska, situated on part of the W\2SE\4 of Section 22, Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, the boundary of such subdivision being more particularly described as follows:

Beginning at the Southeast corner of Lot 1, Block 4, Valley Vista Addition to the City of Scottsbluff, Nebraska, as surveyed and platted; thence south on the west Line of the existing Alley as surveyed and platted in Block 4 and Block 8, Valley Vista Addition, a distance of 869.3 feet; thence southwesterly on the Northerly line of the existing Alley as surveyed and platted in Block 8, Valley Vista a distance of 28.25 feet; thence west on the North Line of such Alley a distance of 138.4 feet to a point 20 feet North of the Northwest corner of Lot 6 of such Block 8, Valley Vista Addition; thence deflect right 900 05 minutes a distance 110.0 feet to a point, such point being on the westerly extension of 14th Street as platted in Block 8, Valley Vista Addition; thence westerly on such extension a distance of 162.0 feet to a point on the southerly extension of the East Line of Block 3, Park Manor Addition to the City of Scottsbluff, as surveyed and platted such point also being 70.0 feet south of the Southeast Corner of Lot 11 of such Block 3, Park Manor Addition; thence North on the extension and East Line of such Block 3, Park Manor Addition to the City of Scottsbluff, a distance of 709.2 feet to the Southeast corner of LOt 1, Block 3 of such Park Manor Addition; thence East and parallel to the South Line of 16th Street a distance of 320.0 feet to the point of beginning, containing an area of 5.61 acres, more or less, of deeded land.

That the accompanying Plat is a true delineation of such survey drawn to a scale of 100 feet to the inch.

That each Lot and Block bears its own number.

That each Block corner is marked with a $5/8" \times 36"$ iron rod and all other corners with $5/8" \times 18"$ iron rods.

That all dimensions are in feet and decimals.

That the boundary of the subdivision is shown on the Plat with a heavy cotted line.

That adjoining lands are shown in broken lines for orientation purposes.
