

SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed Thomson's Addition, Lots One, Two and Three, Block One, to the City of Mitchell, Nebraska, situated on part of the Southwest Quarter of Section Twenty-Two, Township Twenty-Three North, Range Fifty-Six West of the 6th P.M., Scotts Bluff County, Nebraska, the boundary of such subdivision being more particularly described as follows:

Beginning at a point on the North line of 19th Street, as platted in Logan's Addition to the City of Mitchell, such point being on the West line of 13th Street, as platted in Logan's Addition to the City of Mitchell, extended North; thence West on the North line of such 19th Street a distance of 200.0 feet; thence North, parallel with the East line of Lot 8, Barthuly Addition to the City of Mitchell, a distance of 124.30 feet; thence East a distance of 200.0 feet to a point 124.37 feet North of the point of beginning; thence South to the point of beginning, containing an area of 0.57 acres, more or less.

That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch.

That each Lot and Block bears its own number.

That all dimensions are in feet and decimals.

That all corners are marked with 5/8" x 18" iron rods.

That the boundary of the addition is shown on the plat with a heavy dotted line.
