

## SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed a part of the Northeast Quarter of the Southeast Quarter (NE\setailsE\star) of Section Nine (9), Township Twenty—Two (22) North, Range Fifty—five (55) West of the Sixth (6th) P.M., Scotts Bluff County, Nebraska and have further subdivided and platted such part of the NE\star SE\star a Block One (1), Shaver Addition, a subdivision in Scotts Bluff County, Nebraska, the boundary of such Shaver Addition is more particularly described as follows:

Beginning at the Southeast corner of such NE¼SE¼, such corner being 1326.05 feet North of the Southeast corner of Section 9; then West on the South line of such NE¼SE¼, a distance of 560.00 feet; then, a deflection angle to the right of 90 degrees 22 minutes 39 seconds, parallel with the East line of such NE¼SE¼, a distance of 564.35 feet to the Centerline of the Scottsbluff Drainage Ditch; then, a deflection angle to the right of 125 degrees 50 minutes 30 seconds, along the Centerline of the Scottsbluff Drain, a distance of 691.48 feet to the East line of such NE¼SE¼; then, South on the East line of such NE¼SE¼ a distance of 154.40 feet to the point of beginning, containing an area of 4.07 acres, more or less.

That the accompanying plat is a true delination of such survey drawn to a scale of 100 feet to the inch. That all corners are marked with iron rods and that all dimensions are in feet and decimals.
