

SURVEYOR'S CERTIFICATE


I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed a part of the Northwest Quarter of the Southeast Quarter (NW4SE%) of Section Twenty-five (25), Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P.M., Scotts Bluff County, Nebraska and have further subdivided and platted such tract of land into Lot Two (2), Block One (1), South Beltline Tracts a part of the aforesaid NW%SE%. The boundary of the subdivision is more particularly described as follows:

Commencing at the intersection of the South Right of Way Line of the South Beltline Highway and the East Line of Section 25, such point of intersection being 1225.85 feet North of the Southeast corner of such Section 25; then Northwesterly, along the South Right of Way Line of such highway; a distance of 2212.96 feet to the P. T. of a 3 degree 05.8 minute curve to the left; then Northwesterly, along such curve to the left, a distance of 494.55 feet to the P. C. of such curve; then a deflection angle to the left of 90 degrees 00 minutes 00 seconds a distance of 60.00 feet to a point, such point being the P. C. of a 3 degree 12 minute curve, such curve being at right angle to the last described line and parallel to the aforesaid 3 degree 105.8 minute curve; then a deflection angle to the left and in a southeasterly direction along such curve a distance of 101.01 feet to the point of beginning; then a deflection angle to the left of 90 degrees 00 minutes 00 seconds a distance of 60.00 feet to a point on the South Right of Way Line of the Beltline Highway, such point also being on a 3 degree 05.8 minute curve to the right; then a deflection angle to the right of 90 degrees 00 minutes 00 seconds a distance of 177.58 feet; then a deflection angle to the right of 87 degrees 18 minutes 45 seconds a distance of 250.00 feet to the point of beginning, containing an area of 1.16 acres, more or less.

Surveyor's Certificate continued

That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all dimensions are in feet and decimals and that all corners are marked with 5/8" x 36" iron rods. That each Lot and Block bears its own number. That the boundary of the subdivision is shown on the plat with a heavy dotted line.
