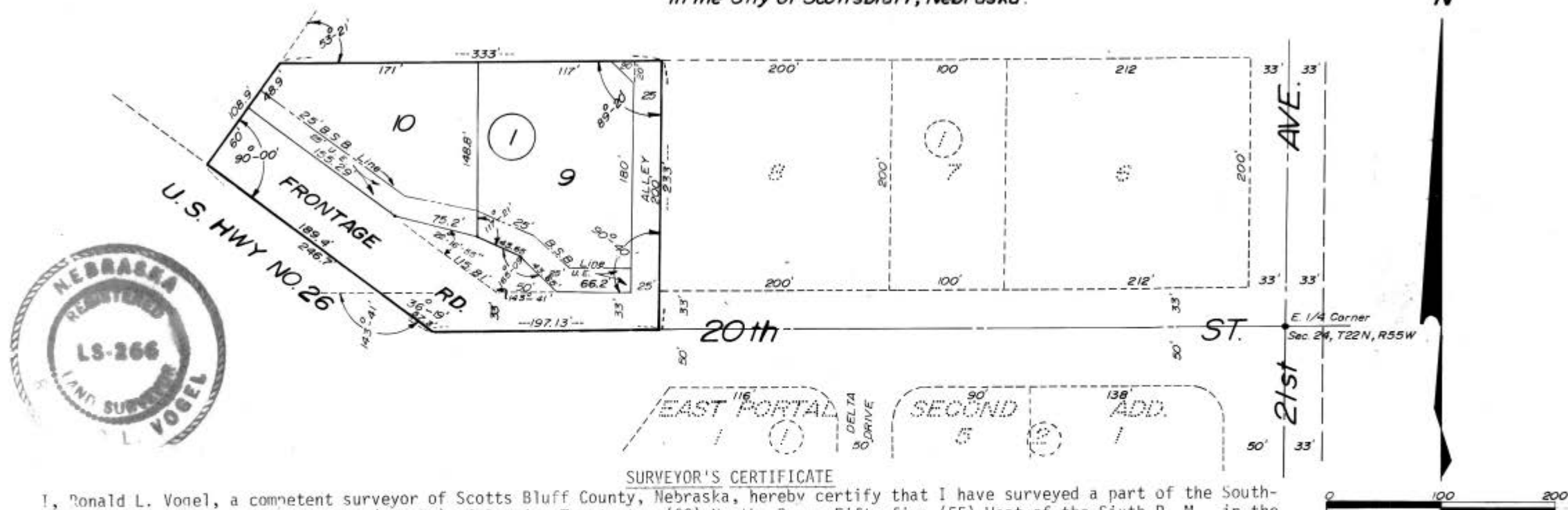

**QUINDT COMMERCIAL TRACTS**  
 Lots 9 and 10, Block 1, a Subdivision  
 in the City of Scottsbluff, Nebraska.



**SURVEYOR'S CERTIFICATE**

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed a part of the Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$ ) of Section Twenty-two (22) North, Range Fifty-five (55) West of the Sixth P. M., in the City of Scottsbluff, Nebraska more particularly described as follows: Beginning at a point 33 feet South of the Southwest Corner of such Lot Eight (8), Block One (1), QUINDT COMMERCIAL TRACTS, an addition to the City of Scottsbluff, Nebraska according to the recorded plat thereof; thence North on the West Line of such Lot Eight (8), a distance of 233 feet to the Northwest Corner of such Lot, thence West on the Westerly extension of the North Line of such Lot Eight (8); a distance of 333.0 feet; thence angle left 53 degrees and 21 minutes, a distance of 108.9 feet to intersect the Northeast Line of the Right of Way of U. S. Highway No. 26; thence Southeasterly on such Northeast Line, a distance of 246.7 feet to a point intersecting the South Line of the aforementioned Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$ ); thence East on such South Line, a distance of 197.13 feet to the point of beginning, containing 1.74 acres, more or less.

That the above described land has been surveyed and delineated as Lots 9 and 10, Block One (1), QUINDT COMMERCIAL TRACTS with adjoining alley Frontage Road and 20th Street thereto. That the accompanying plat is a correct delineation of such survey drawn to a scale of 100 feet to One inch with all dimensions shown thereon in feet and decimals. That 5/8" x 36" Iron Rods are driven well into the ground at each corner of each Lot as shown. That each Lot bears its own number. That the boundaries of the subdivision are shown on the accompanying plat in heavy solid lines and the dashed line of adjoining subdivisions are for orientation purposes only.

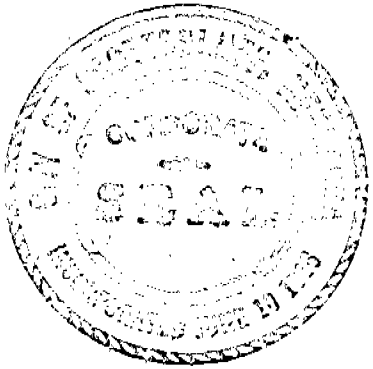
