SURVEYOR'S CERTIFICATE

I, M. C. Schaff, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed and subdivided SCHOLL SUBDIVISION, a part of the Northeast Quarter of the Northeast Quarter (NE4NE4) of Section Thirty-five (35), Township Twenty-two (22) North, Range Fifty-five (55) West, of the 6th P. M., Scotts Bluff County, Nebraska, the boundary of such survey and subdivision being more particularly described as follows:

Commencing at the Southeast Corner of said NE4NE4, thence West, along the South Line of said NEANE, a distance of 33.0 feet, thence a deflection angle right of 90 degrees 26 minutes, a distance of 20.0 feet to the Point of Beginning, thence a deflection angle left of 90 degrees 26 minutes, a distance of 764.54 feet, along the North Right of Way Line of Country Club Road, thence a deflection angle right of 90 degrees 29 minutes, a distance of 404.17 feet to the South Right of Way Line of the Central Irrigation District Canal; thence a deflection angle right of 105 degrees 17 minutes, along said South Right of Way Line, a distance of 651.0 feet; thence a deflection angle right of 11 degrees 21 minutes, along said Right of Way, a distance of 68.1 feet; thence a deflection angle right of 22 degrees 28 minutes, along said Right of Way, a distance of 115.75 feet; thence a deflection angle right of 40 degrees 51 minutes, a distance of 107.86 feet to the Point of Beginning, containing an area of _____s.12___acres, more or less.
