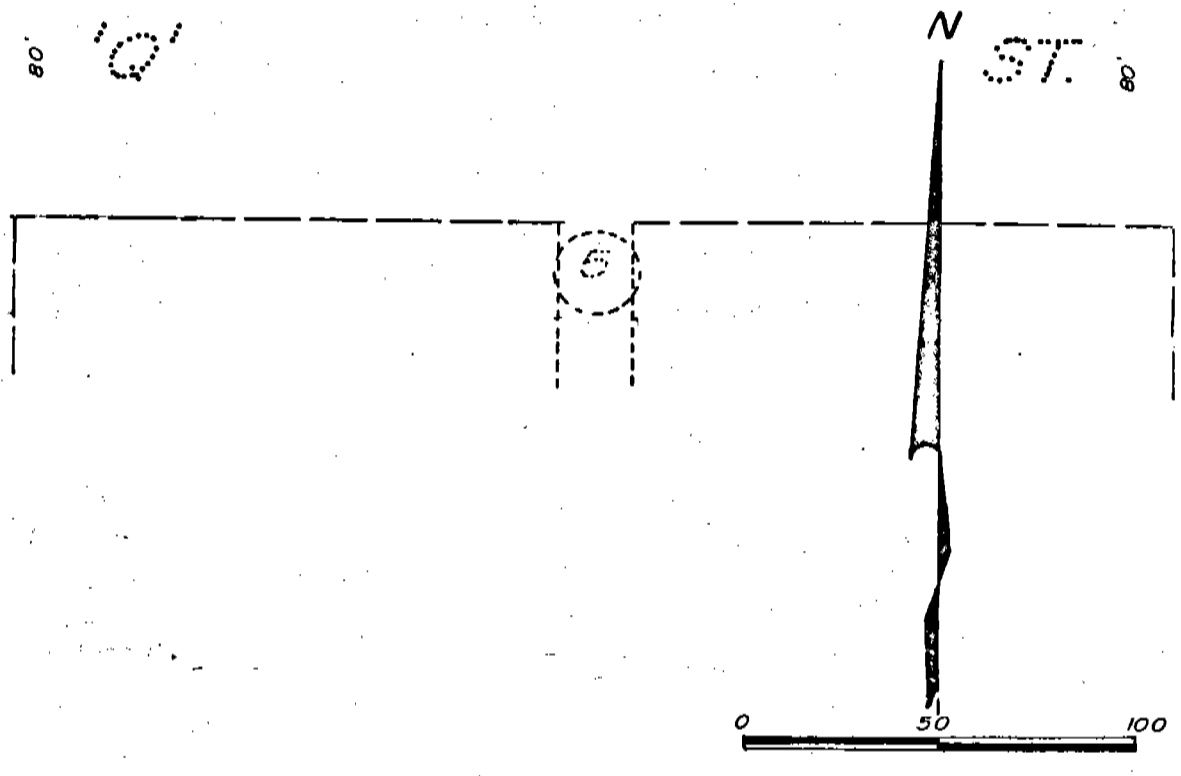
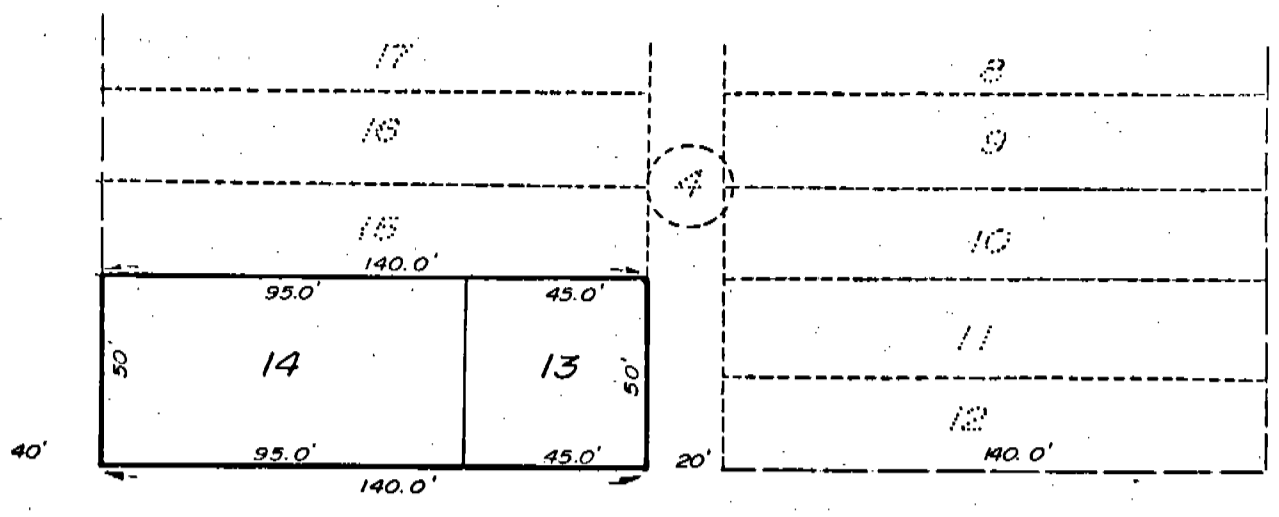

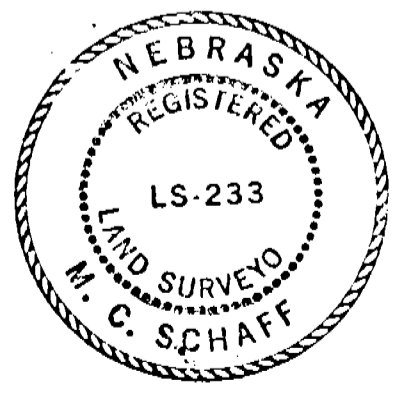


SURVEYOR'S CERTIFICATE

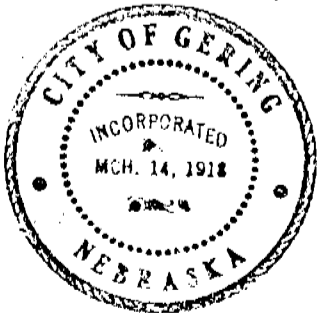
