

### SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County. Nebraska, hereby certify that I have surveyed "WEIMER SUBDIVISION" of Lot Eight(5) and part of Lot Nine(9), Lingle and Reids Second Addition to the City of Mitchell, Nebraska.

That part of Lot 9 included within this subdivision is more particularly described as follows:

Boginning at a point on the East Line of such Lot 9, 235 feet South of the Northeast corner of such Lot 9; then South on the East Line of such Lot 9 a distance of 104.52 feet; then West a distance of 56.0 feet; then North, parallel to the East Line of such Lot 9 a distance of 103.9 feet; then East a distance of 56.0 feet to the point of beginning.

That such subdivision of Lot 8 and part of Lot 9 is to be known as "Weimer Subdivision" and consists of Lots One through Five and public streets therein.

That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all corners are marked with iron rods and that all dimensions are in feet and decimals. That the boundary of the subdivision is shown on the plat with a heavy solid line and adjoining subdivisions in dashed lines for orientation purposes. That each Lot bears its own number.
