

SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed a part of the Southwest Quarter of the Southwest Quarter (SW_{4}^{1} SW_{4}^{1}) of Section Thirty-five (35) Township Twenty-two (22) North, Range Fifty-five (55)West of the 6th P.M., Scotts Bluff County, Nebraska; the boundary of such tract being more particularly described as follows:

With reference to the Southeast corner of such SW_4^1 SW_4^1 ; then North on the East Line of such SW_4^1 SW_4^1 a distance of 625.00 feet to the point

of beginning;

then a deflection angle to the left of 90° 15' 15" a distance of 16.5 feet; then a deflection angle to the left of 89° 44' 45" a distance of 30.0 feet; then a deflection angle to the right of 89° 44' 45" a distance of 373.09 feet; then a deflection angle to the right of 90° 15' 15" a distance of 185.0 feet; then a deflection angle to the right of 89° 44' 45" a distance of 389.59 feet to the East Line of such SW_4^{\downarrow} SW_4^{\downarrow} ; then South on such East Line a distance of 155.0 feet to the point of beginning, containing an area of 164 acres, more or less.

That I have further surveyed and subdivided such land as above described as "Sorenson Addition" as addition to the City of Gering, Nebraska.

That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all corners are marked with iron rods and that all dimensions are in feet and decimals. That the boundary of the subdivision is shown on the plat with a heavy solid line and that adjoining area is dashed lines for orientation purposes.
