## SURVEYOR'S CERTIFICATE

I, M. C. Schaff, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed and prepared a plat of WAITE SUBDIVISION, Lots One (1) through Five (5), Block One (1) and Block Two (2), a replat of Tracts Seven (7) through Eleven (11), Mildy and Lana Commercial Tracts, situated in part of the Southeast Quarter of the Southeast Quarter (SE\section SE\section) of Section Twenty-Four (24), Township Twenty-Two (22) North, Range Fifty-Five (55) West of the Sixth (6th) Principle Meridian (P.M.), Scotts Bluff County, Nebraska, the boundary of such survey being more particularly described as follows:

Commencing at the Southeast Corner of Section 24; thence, Westerly, along the South Line of Section 24, a distance of 698.2 feet; thence, a deflection angle to the right of 90 degrees 51 minutes 30 seconds, a distance of 33.0 feet to the Point of Beginning; thence, continuing on the last described course, also being the West Right of Way Line of 19th Avenue, a distance of 602.0 feet; thence, a deflection angle left of 90 degrees 51 minutes 30 seconds, along the South Right of Way Line of 15th Street, a distance of 637.99 feet; thence, a deflection angle left of 89 degrees 10 minutes 00 seconds, along the East Right of Way Line of 17th Avenue, a distance of 172.0 feet; thence, a deflection angle left of 90 degrees 50 minutes 00 seconds, a distance of 190.0 feet; thence, a deflection angle right of 90 degrees 50 minutes 00 seconds, a distance of 430.0 feet; thence, a deflection angle left of 90 degrees 50 minutes 00 seconds, along the North Right of Way Line of East Overland Drive, a distance of 447.76 feet; to the Point of Beginning, containing an area of 6.48 acres, more or less.

That the accompanying replat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all Block Corners are marked with 3/4" x 36" iron rods and that all Lot Corners are marked with 3/4" x 18" iron rods. That all dimensions are in feet and decimals. That the dashed lines shown on the plat are for orientation purposes only and that the boundary of the survey and replat are shown with a heavy solid line.
