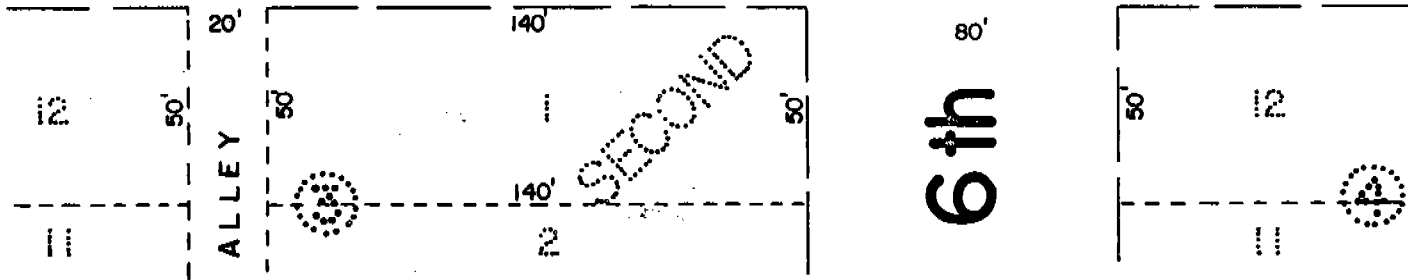
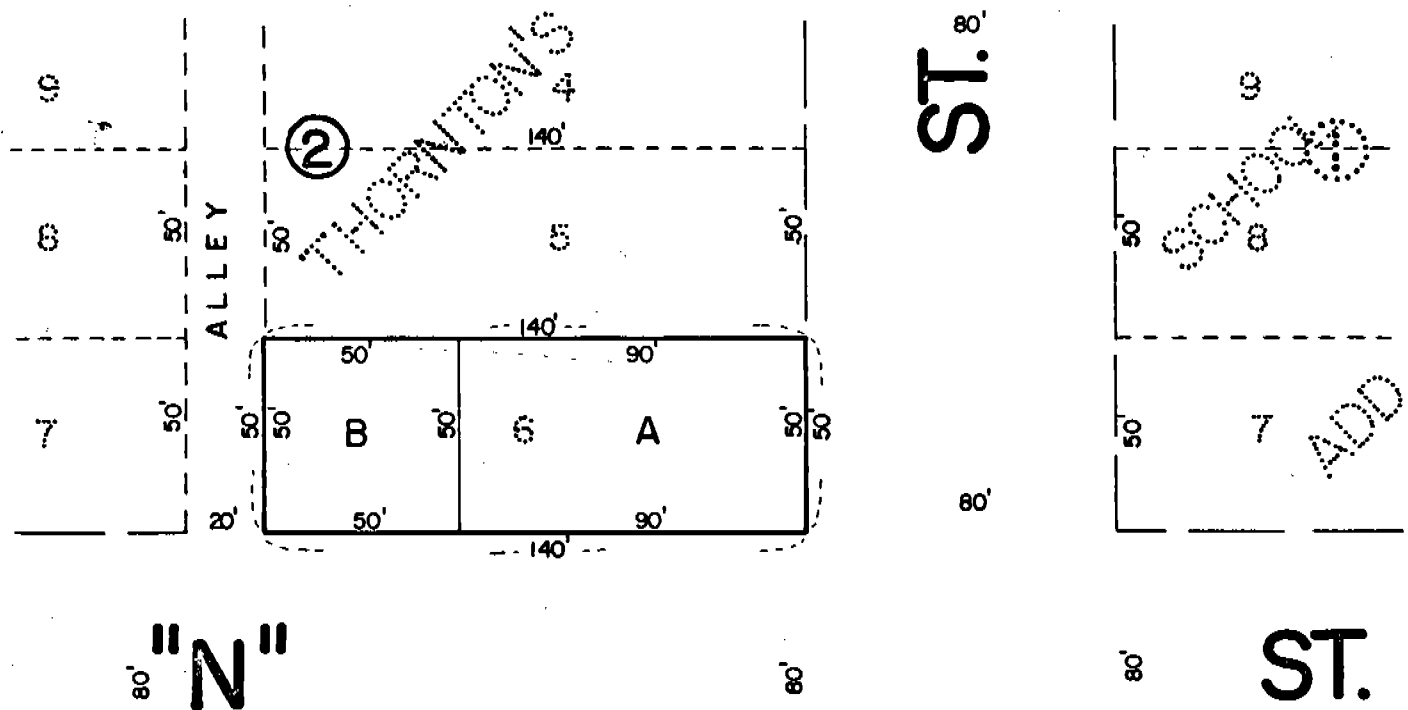

OF LOT 6, BLOCK 2, THORNTON'S SECOND ADDITION TO THE CITY OF GERING, NEBR.

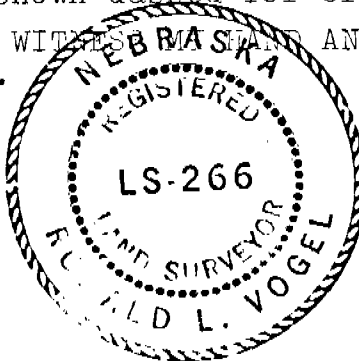
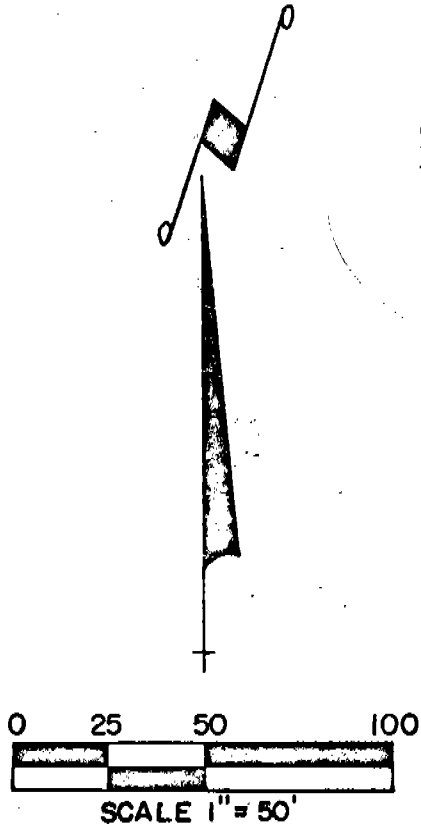


SURVEYOR'S CERTIFICATE
