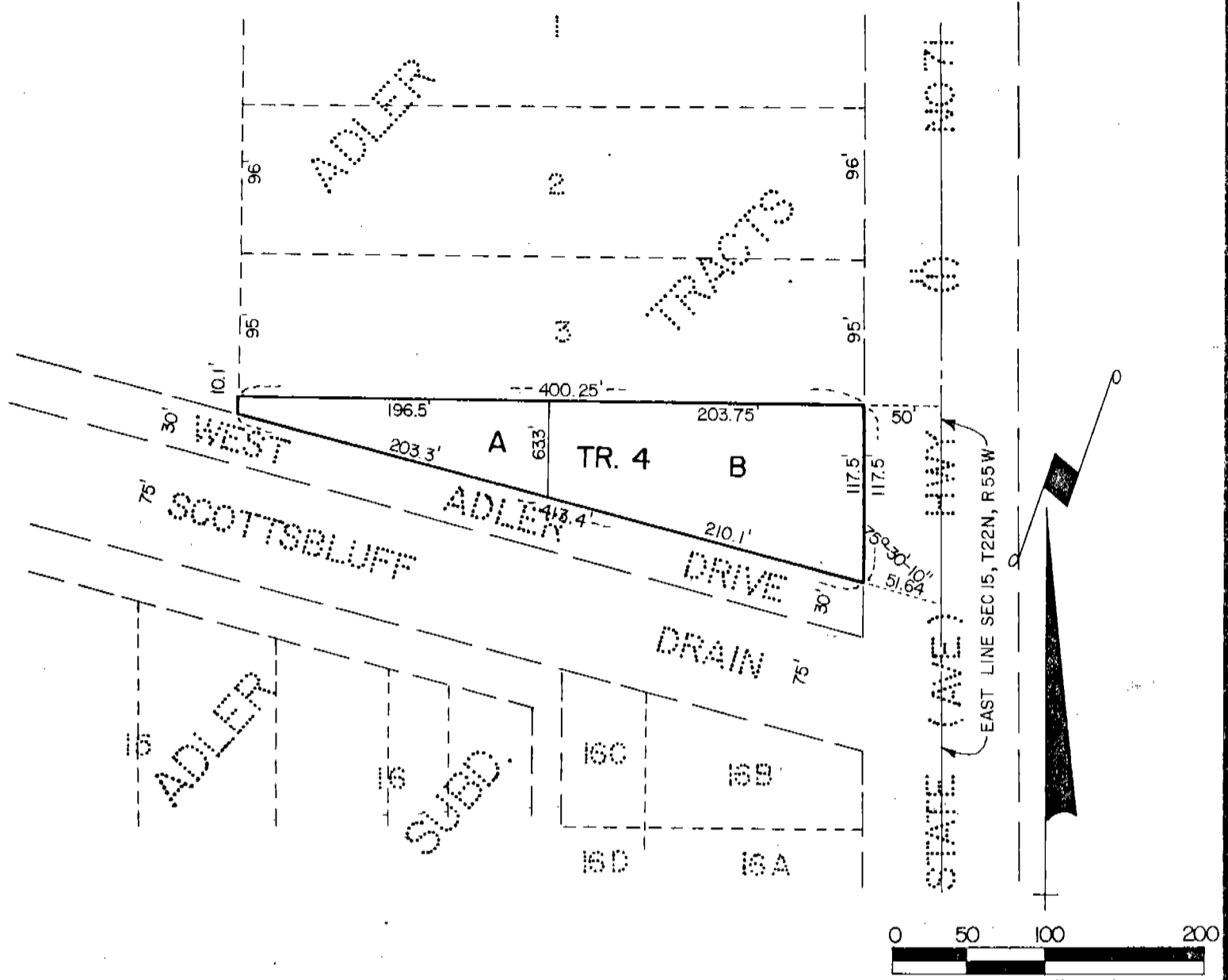

T22N, R55W OF THE 6th P.M., SCOTTS BLUFF COUNTY, NEBRASKA

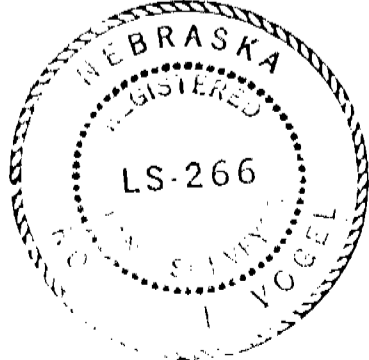


SURVEYOR'S CERTIFICATE

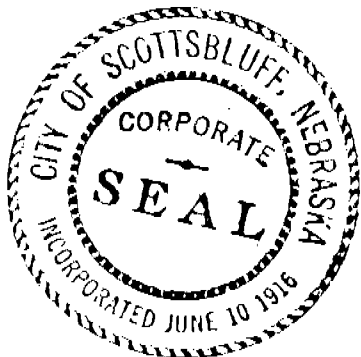
