SURVEYOR'S CERTIFICATE

I, M. C. Schaff, a competent surveyor of Scotts Bluff County, Nobraska, hereby certify that I have surveyed NORTHWOOD ADDITION, LOT TWO (2), BLOCK ONE (1), and LOTS ONE (1) THROUGH NINE (9), BLOCK TEN (10) an addition to the City of Scottsbluff, Nebraska, and prepared a replat of said lots to be known as NORTHWOOD ADDITION - REPLAT, A replat of LOT TWO (2), BLOCK ONE (1) and LOTS ONE (1) THROUGH THIRTEEN (13), BLOCK TEN (10) NORTHWOOD ADDITION, situated on a part of the Southwest Quarter (SE4) of Section Fourteen (14), Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P.M., Scotts Bluff County, Nebraska, the boundary of such subdivision being more particularly described as follows:

With reference to the Northwest corner of such Southwest Quarter; thence south on the West Line of such Southwest Quarter a distance of 1228.3 feet to a point, such point being 1425.0 feet North of the Southwest corner of such Southwest Quarter; thence a deflection angle to the left of 90 degrees 17 minutes 05 seconds a distance of 33.0 feet to the point of beginning thence a deflection angle to the left of 89 degrees 42 minutes 55 seconds parallel to the West Line of such Southwest Quarter; a distance of 1088.38 feet along the Easterly Right of Way Line of Highway 71 to a point; then a deflection angle to the right of 13 degrees 42 minutes 00 seconds, along such Right of Way Line a distance of 123.60 feet to intersect the South Right of Way Line of U. S. Highway No. 26; thence a deflection angle to the right of 75 degrees 49 minutes 00 seconds, along such Right of Way Line, a distance of 372.70 feet; thence a deflection angle to the right of 90 degrees 18 minutes 30 seconds a distance of 833.6 feet; thence a deflection angle to the right of 89 degrees 43 minutes 25 seconds a distance of 270.0 feet; thence a deflection angle to the left of 89 degrees 43 minutes 25 seconds a distance of 375.0 fect to the Northeast corner of Lot 1, Block 1, Northwood Addition, as platted; thence a deflection angle to the right of 89 degrees 42 minutes 55 seconds, on the North Line of such Lot 1, a distance of 132.0 feet to the point of beginning, containing an area of 8.84 acres, more or less.

That the accompanying replat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all block corners are marked with 3/4" x 36" iron rods and that all lot corners are marked with 3/4" x 18" iron rods, and that all dimensions are in feet and decimals. That each lot and Block bears its own number and that the boundary of the subdivision is shown on the plat with a heavy, solid line.
