

Schaff, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed a aprt of the SE4 of Section 22, Township 22 North, Range 55 West, and prepared a plat to be known as VALLEY VISTA ADDITION, Block 9, an Addition in the City of Scottsbluff, Nebraska, the boundary of said survey being more particularly described as follows:

Beginning at the Northwest Corner of Lot 7, Block 8, Valley Vista Addition; thence, West, along the South Right-of-Way of 14th Street, a distance of 86.0 feet; thence, South and parallel to the West Line of Block 8, Valley Vista Addition, a distance of 280.0 feet; thence, East, on the North Right-of-Way of West Overland Drive, a distance of 86.0 feet; thence, North, on the West Line of Block 8, Valley Vista Addition, a distance of 280.0 feet, to the point of beginning, containing an area of 0.55 acres more or less.
