

"SURVEYOR'S CERTIFICATE"

I, Duane E. Stott, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed and prepared a plat of a tract of land located in a part of the Southwest Quarter of the Northeast Quarter (SWM NEM) of Section Fourteen (14) Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P.M., Scotts Bluff County, Nebraska, such tract and plat to be known as TRACT THREE, ROSS THIRD SUBDIVISION and part of 37th Street, the boundary of such tract and plat being more particularly described as follows:

Beginning at the Southeast Corner of Tract 2, ROSS THIRD SUBDIVISION, in the City of Scottsbluff, Nebraska; thence, easterly, on the North Line of Tract 1 of ROSS THIRD SUBDIVISION, a distance of 200.0 feet; thence, a deflection angle left of 89 degrees 39 minutes 00 seconds, a distance of 150.0 feet; thence, a deflection angle left of 90 degrees 21 minutes 00 seconds, a distance of 200.0 feet; thence, a deflection angle left of 89 degrees 39 minutes 00 seconds, a distance of 150 feet to the Point of Beginning, containing an area of 0.69 acres, more or less.

That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all dimensions are in feet and decimals and that all corners are marked with 3/4" x 18" iron rods, driven well into the ground. That the tract bears its own number. That the boundary of the survey is shown on the plat with a heavy solid line.
