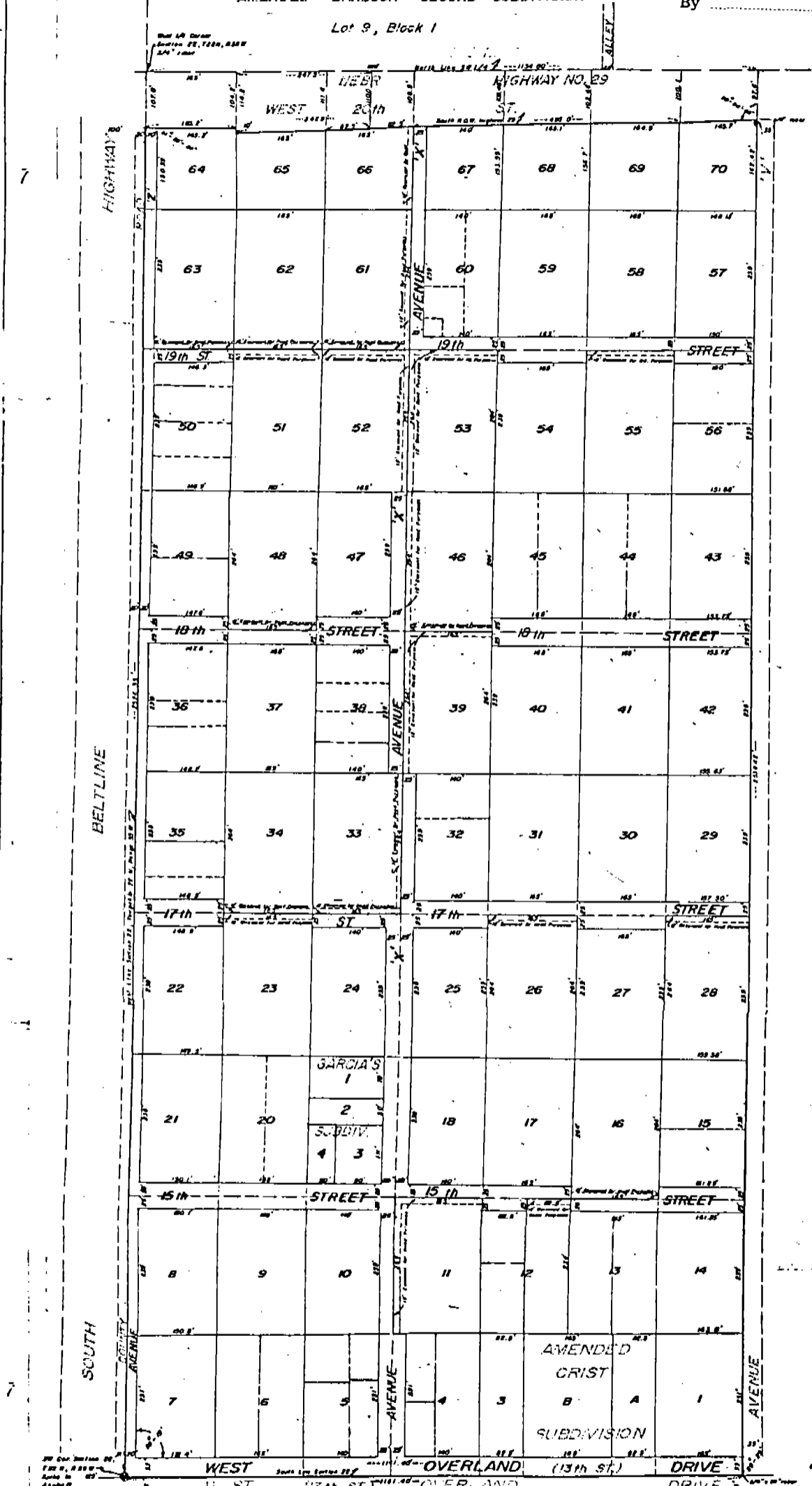

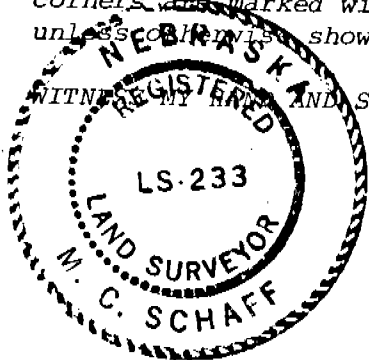

SURVEYOR'S CERTIFICATE

I, M.C. Schaff, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed and prepared a plat of part of the Southwest Quarter (SW $\frac{1}{4}$) of Section Twenty-two (22), Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P.M., Scotts Bluff County, Nebraska, now platted and recorded as "R.S. HUNT'S TRACT", to be known as "AMENDED PLAT OF R.S. HUNT'S TRACT", in the City of Scottsbluff, Nebraska, the boundary of said plat being more particularly described as follows:

Beginning at the Southwest Corner of Section 22; thence, East on the South Line of Section 22, said line being the South Line of R.S. Hunt's Tract, as previously recorded, a distance of 1161.40 feet to the East Line of R.S. Hunt's Tract as previously recorded; thence, a deflection angle left of 89 degrees 25 minutes 00 seconds and on the East Line of R.S. Hunt's Tract, a distance of 2538.42 feet to the South Right-of-Way Line of Nebraska Highway No. 29; thence, a deflection angle left of 90 degrees 50 minutes 05 seconds, on said Right-of-Way, a distance of 145.7 feet to a point on the East Line of Lot 69, R.S. Hunt's Tract, said point being 100.1 feet south of the North Line of the Southwest Quarter; thence, continuing west on said South Right-of-Way, a distance of 495.0 feet to a point on the East Line of Lot 66, R.S. Hunt's Tract as previously recorded; said point being 108.5 feet South of the North Line of the Southwest Quarter; thence, continuing West on the last described course, a distance of 82.5 feet to a point on the West Line of the East Half of Lot 66, R.S. Hunt's Tract as previously recorded; said point being 110.0 feet south of the North Line of the Southwest Quarter; thence, continuing on the last described course, a distance of 247.5 feet to a point on the West Line of Lot 65, R.S. Hunt's Tract as previously recorded; said point being 114.2 feet south of the North Line of the Southwest Quarter; thence, North, on said West Line of said Lot 65, a distance of 10.0 feet to a point which is 104.2 feet south of the North Line of the Southwest Quarter; thence, continuing West on the South Right-of-Way of Nebraska Highway No. 29, a distance of 165.2 feet to the West Line of Section 22, said line being the West Line of R.S. Hunt's Tract as previously recorded; thence, South on said West Line, a distance of 2526.39 feet to the point of beginning, containing an area of 66.7 acres more or less. The "AMENDED PLAT OF R.S. HUNT'S TRACT" includes "GARCIA'S SUBDIVISION".

That the accompanying plat is a true delineation of said survey drawn to a scale of 100 feet to the inch. That all dimensions are in feet and decimals, that all corners are marked with 3/4 inch by 36 inch iron rods driven well into the ground, unless otherwise shown. That the boundary of the plat is shown with a heavy solid line.
