

SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed a part of the North Half of the Southwest Quarter (N_2^1 SW $_4^1$) of Section Fourteen (14), Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P.M., Scotts Bluff County, Nebraska, and prepared a plat to be known as Lots 1 through 6, Block 8, NORTHWOOD ADDITION in the City of Scottsbluff, Nebraska, the boundary of such tract of land being more particularly described as follows:

Beginning at the Northeast Corner of Lot 14, Block 4, NORTHWOOD ADDITION, as previously recorded; said point being on the West Line of Avenue 'D'; thence, North on said West Line, a distance of 70.0 feet to the point of beginning; thence, continuing North on said West Line, a distance of 475.39 feet to the South Line of U.S. Highway No. 26; thence, a deflection angle left of 72 degrees 49 minutes 32 seconds on said South Line, a distance of 313.90 feet; thence, a deflection angle left of 107 degrees 10 minutes 28 seconds, a distance of 569.95 feet to the North Line of 33rd Street; thence, a deflection angle left of 90 degrees 20 minutes 06 seconds, on said North Line, a distance of 300.0 feet to the point of beginning, containing an area of 3.60 acres more or less.

That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all block corners are marked with $3/4^{\prime\prime}$ x $36^{\prime\prime}$ iron rods and that all lot corners are marked with $3/4^{\prime\prime}$ x $18^{\prime\prime}$ iron rods, and that all dimensions are in feet and decimals. That each Lot and Block bears its own number and that the boundary of the subdivision is shown on the plat with a heavy, solid line.
