

# PLAT AND DEDICATION OF PART OF 27th STREET



#### SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed a tract of land in the South Half  $(S^{\frac{1}{2}})$  of Section Thirteen (13), Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P.M., Scotts Bluff County, Nebraska, to be known as part of 27th Street, said Tract being more particularly described as follows:

Beginning at a point on the South line of said Section 13, said point being 30.0 feet West of the Southwest Corner of the Southeast Quarter of Section 13; thence, a deflection angle right of 90 degrees 38 minutes, a distance of 50.0 feet; thence, a deflection angle right of 89 degrees 22 minutes, a distance of 236.5 feet to the West line of the Scotts Bluff County College Tract as previously recorded; thence, a deflection angle right of 90 degrees 38 minutes, a distance of 50.0 feet to the South line of Section 13; thence, a deflection angle right of 89 degrees 22 minutes, a distance of 236.5 feet to the point of beginning, containing an area of 0.27 acres more or less.

That the accompanying plat is a true delineation of such survey drawn to a scale of That all corners are marked as shown and that all dimensions are 100 feet to the inch. in feet and decimals. That the dashed lines shown on the plat are for orientation purposes only.
