
SUNNYSIDE SUBDIVISION REPLAT

SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed and prepared a Replat of Vacated Lots 1 and 2, Block 1, Waite Subdivision in the City of Scottsbluff, and that said Replat will be known as Lots 1 through 3, SUNNYSIDE SUBDIVISION REPLAT, more particularly described as follows:

Beginning at the Northwest Corner of Block 1, Brandt's Addition, as previously recorded, said Northwest corner also being on the East Right-of-Way line of 17th Avenue; thence, northerly on the East Right-of-Way line of 17th Avenue, a distance of 172.0 feet to the point of intersection with the South Right-of-Way line of 15th Street; thence, a deflection angle right of 89 degrees 10 minutes on the South Right-of-Way line of 15th Street, a distance of 190.0 feet; thence, a deflection angle right of 90 degrees 50 minutes, a distance of 172.0 feet to the Northeast corner of Block 1, Brandt's Addition; thence, a deflection angle right of 89 degrees 10 minutes on the North line of Block 1, Brandt's Addition, a distance of 190.0 feet to the point of beginning, containing an area of 0.75 acres more or less.

That the accompanying plat is a true delineation of such Replat drawn to a scale of 100 feet to the inch. That the boundary of the Replat is shown with a heavy solid line and that the dashed lines are shown for orientation purposes. That each lot bears its own number and that all totacorpers are marked as shown.
