

SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed and subdivided Lot 38, Block 1, Woodstock Hills, a subdivision of part of the West Half of the Northeast Quarter of Section 26, Township 23 North, Range 56 West of the 6th P.M., Scotts Bluff County, Nebraska, and that the subdivisional line of said Lot 38 begins at a point which is 19.62 feet northeasterly of the Northwest corner of Lot 38 as measured along the arc of the Cul-desac on which Lot 38 has frontage and extends southeasterly to the northerly alley cut off point at the rear of said Lot and that the length of said subdivisional line is 115.80 feet and that the newly formed lots on either side of the above described line shall be known as Lots 38A and 38B, Block One, Woodstock Hills Subdivision.
