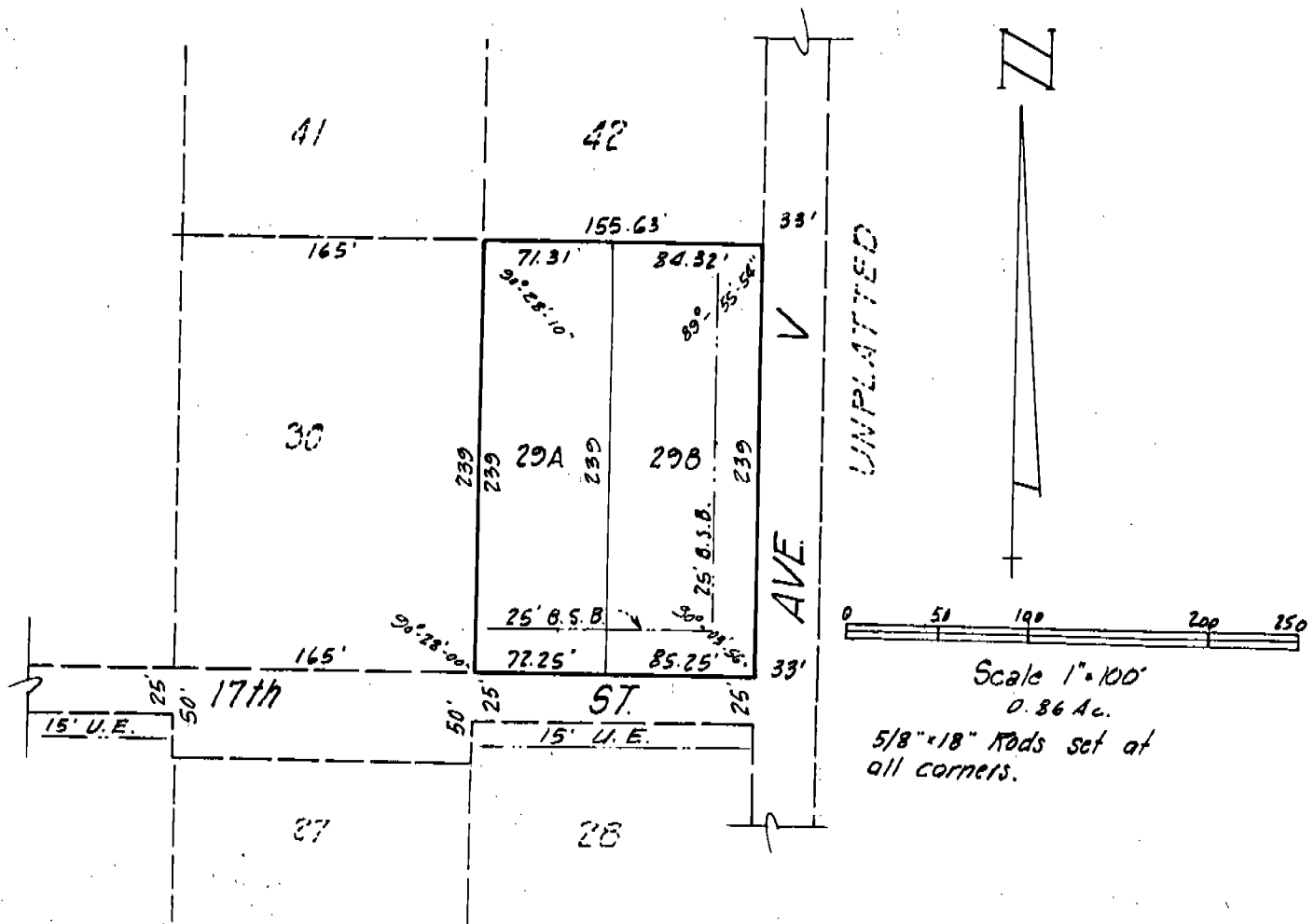

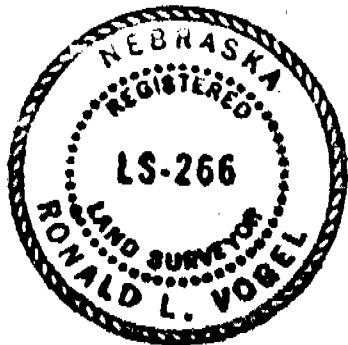
### SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed Tract 29, Amended R. S. Hunt's Tract, an Addition in the City of Scottsbluff, Nebraska, according to the recorded plat thereof.

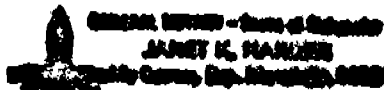

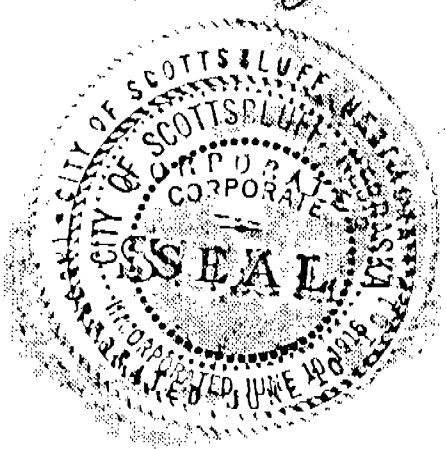
