

## SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed and prepared a plat of part of the Southeast Quarter of Section 30 and part of the Northeast Quarter of Section 31, Township 22 North, Range 54 West of the 6th P.M., Scotts Bluff County, Nebraska, to be known as LOT 2, BLOCK 1, SECOND IMMIGRANT TRAIL SUBDIVISION, the boundary of which is more particularly described as follows:

With reference to the Northeast corner of Section 31; thence, westerly on the North line of Section 31, a distance of 715.88 feet to the TRUE POINT OF BEGINNING, said point of beginning also being on the West Right-of-Way line of Immigrant Trail Drive, as previously dedicated; thence, a deflection angle right of 57 degrees 48 minutes 27 seconds, a distance of 215.39 feet; thence, a deflection angle left of 90 degrees 00 minutes 00 seconds, a distance of 722.57 feet to the point of intersection with the North Right-of-Way line of the Burlington-Northern Railroad; thence, a deflection angle left of 124 degrees 42 minutes 56 seconds on said North Right-of-Way line, a distance of 640.25 feet; thence, a deflection angle left of 90 degrees 00 minutes · - 00 seconds, a distance of 335.89 feet; thence, a deflection angle right of 28 degrees 21 minutes 44 seconds, a distance of 53.70 feet; thence, a deflection angle right of 90 degrees 00 minutes 00 seconds to the tangent of a curve to the left, said curve having a radius of 50.00 feet and a central angle of 60 degrees 11 minutes 40 seconds; thence, southeasterly on the arc of said curve, a distance of 52.53 feet to the point of intersection with the West Right-of-Way line of Immigrant Trail Drive, as previously dedicated, said West Right-of-Way line being on a curve convex to the last described curve and having a radius of 3004.80 feet and a central angle of 11 degrees 25 minutes 02 seconds; thence, a deflection angle left from the tanget of the first described curve to the Point of Tangency of the 2nd described curve of 113 degrees 21 minutes 35 seconds; thence, northwesterly on the West Right-of-Way line of Immigrant Trail Drive, being the arc of the 2nd described curve, a distance of 129.29 feet to the Point of Tangency of said 2nd described curve; thence, northwesterly, tangent to said 2nd described curve, a distance of 24.85 feet to the point of beginning, containing an area of 5.572 acres more or less.

That the accompanying plat is a true delineation of such survey and subdivision drawn to a scale of 100 feet to the inch. That all corners are marked with 3/4" x 18" iron rods driven well into the ground. That all dimensions are in feet and decimals and that the boundary of the survey is shown on the plat with a heavy solid line. That dashed lines are shown for orientation purposes.
