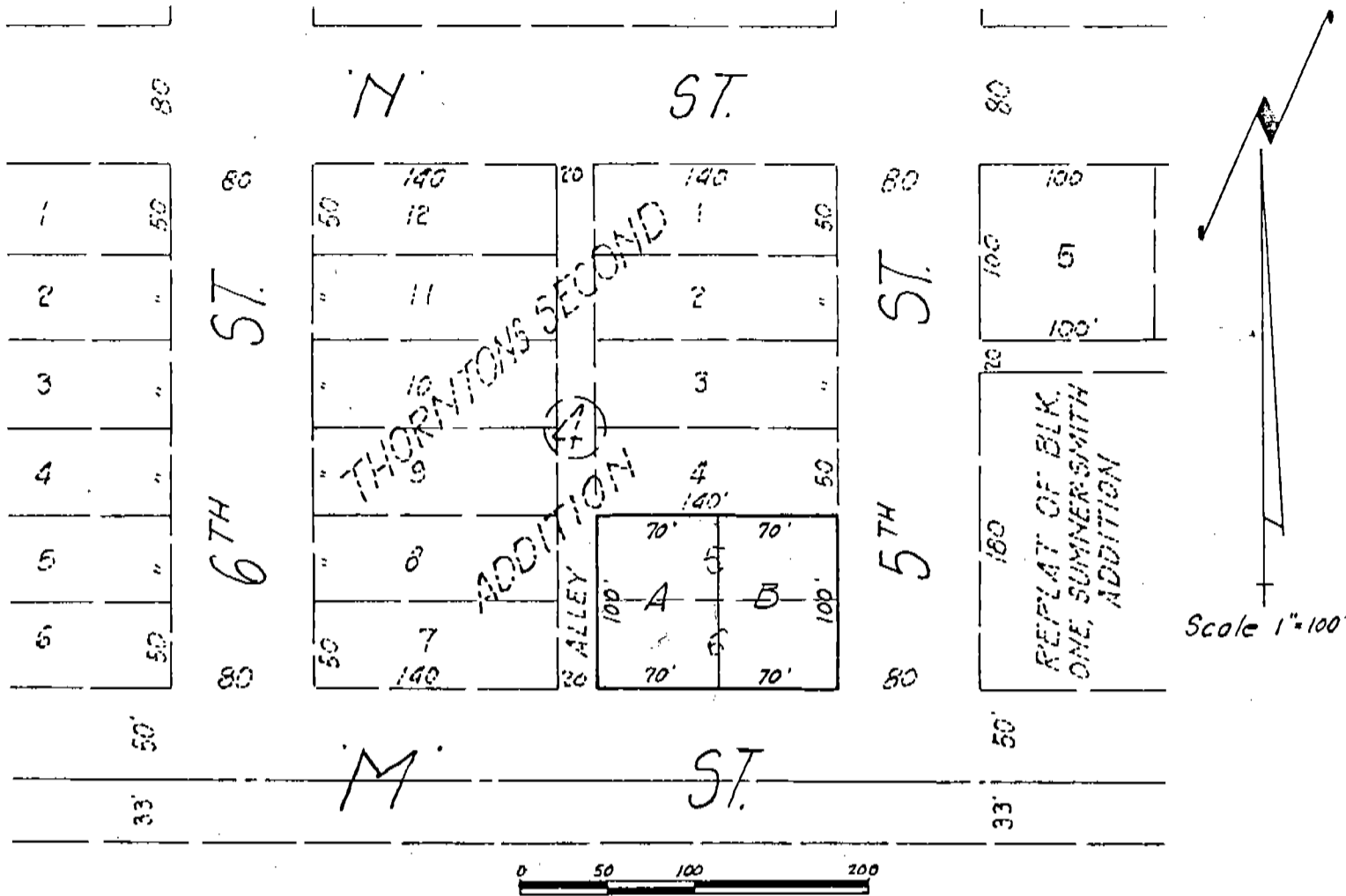

SURVEYOR'S CERTIFICATE
