

SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed and prepared a plat of "NORTHWESTERN ESTATES REPLAT", Block 1, Lots 1, 2, 3 & 4, and part of 36th Street, said tract being comprised by sign Block 5, George Baltes Addition, an Addition in the City of Scottsbluff, Nebraska, and the East-West alley adjoining the south line of said Lot 4 to include that triangular part of said alley formed by the southerly and westerly extensions of the westerly and southerly lines, respectively, of said Lot 4.
