SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of Lots 2A and 2B, a Replat of Lot 2, Block 1, Second Immigrant Trail Subdivision, as previously recorded, the boundary of which is more particularly described as follows:

With reference to the Northeast corner of Section 31; thence, westerly on the North line of Section 31, a distance of 715.88 feet to the TRUE POINT OF BEGINNING, said point of beginning also being on the West Right-of-Way line of Immigrant Trail Drive, as previously dedicated; thence, a deflection angle right of 57 degrees 48 minutes 27 seconds, a distance of 215.39 feet; thence, a deflection angle left of 90 degrees 00 minutes 00 seconds, a distance of 722.57 feet to the point of intersection with the North Right-of-Way line of the Burlington-Northern Railroad; thence, a deflection angle left of 124 degrees 42 minutes 56 seconds on said North Right-of-Way line, a distance of 640.25 feet; thence, a deflection angle left of 90 degrees 00 minutes 00 seconds, a distance of 335.89 feet; thence, a deflection angle right of 28 degrees 21 minutes 44 seconds, a distance of 53.70 feet; thence, a deflection angle left of 90 degrees 00 minutes 00 seconds to the tangent of a curve to the right, said curve having a radius of 50.00 feet and a central angle of 71 degrees 40 minutes 37 seconds; thence, northeasterly on the arc of said curve, a distance of 62.55 feet to the point of intersection with the West Right-of-Way line of Immigrant Trail Drive, as previously dedicated, said West Right-of-Way line being on a curve convex to the last described curve and having a radius of 3004.80 feet and a central angle of 11 degrees 25 minutes 02 seconds; thence, northwesterly on the West Right-of-Way line of Immigrant Trail Drive, being the arc of the 2nd described curve, a distance of 37.65 feet to the Point of Tangency of said 2nd described curve; thence, northwesterly, tangent to said 2nd described curve, a distance of 24.85 feet to the point of beginning, containing an area of 5.56 acres more or less.

That the accompanying plat is a true delineation of such survey and Replat drawn to a scale of 100 feet to the inch. That all corners are marked with $3/4"\times18"$ iron rods driven well into the ground. That all dimensions are in feet and decimals and that the boundary of the survey is shown on the plat with a heavy solid line. That dashed lines are shown for orientation purposes.
