
NORTHWOOD ADDITION

SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed a part of the North Half of the Southwest Quarter of Section 14, Township 22 North, Range 55 West of the 6th P.M., in the City of Scottsbluff, Scotts Bluff County, Nebraksa, the boundary of which is more particularly described as follows:

With reference to the Southwest corner of Lot 3, Block 8, Northwood Addition; thence, westerly on the South line of said Lot 3, extended west, also being the North Right-of-Way line of 33rd Street, a distance of 20.00 feet to the TRUE POINT OF BEGINNING; thence, a deflection angle right of 90 degrees 20 minutes 06 seconds on the West line of a previously dedicated alley, a distance of 569.75 feet to the point of intersection with the South Rightof-Way line of U.S. Highway #26; thence, a deflection angle left of 72 degrees 49 minutes 32 seconds, on said South Right-of-Way line, a distance of 68.30 feet to the Point of Curvature of a curve to the left, said curve having a radius of 3729.72 feet and a central angle of 02 degrees 30 minutes 40 seconds; thence, northwesterly on the arc of said curve, a distance of 163.44 feet to the Point of Tangency of said curve; thence, southwesterly on the radius of said curve, a distance of 150.00 feet to the point of intersection with the arc of a curve concentric with the last described curve; thence, northwesterly on the arc of said curve, a distance of 20.01 feet; thence, southwesterly on the radius of said curve, a distance of 70.00 feet; thence, a deflection angle left of 14 degrees 41 minutes 30 seconds, a distance of 429.60 feet to the point of intersection with the North Right-of-Way line of 33rd Street; thence, a deflection angle left of 90 degrees 20 minutes 06 seconds on said North line, a distance of 298.00 feet to the point of beginning, containing an area of 3.99 acres.

That I have prepared a plat of such tract of land to be known as Northwood Addition, containing parts of Blocks 9 and 13, Northwood Street, Avenue E and two alleys. That the Blocks, Street, Avenue and alleys are well and accurately staked off and marked. That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all dimensions are in feet and decimals. That all Block corners are marked with $3/4^{\prime\prime}$ x $36^{\prime\prime}$ iron rods and all Lot corners are marked with $3/4^{\prime\prime}$ x $36^{\prime\prime}$ iron rods and all Lot corners are marked with a heavy solid line.
