## SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed a part of the Northeast Quarter of Section 27, Township 22 North, Range 55 West of the 6th P.M., in the City of Scottsbluff, Scotts Bluff County, Nebraska, more particularly described as follows.

Beginning at the Northeast corner of Section 27; thence, southerly on the East line of said Section, a distance of 1017.00 feet; thence, a deflection angle right of 97 degrees 45 minutes 50 seconds, a distance of 202.31 feet; thence, a deflection angle right of 82 degrees 38 minutes 55 seconds, a distance of 992.02 feet to the point of intersection with the North line of said Northeast Quarter; thence, a deflection angle right of 89 degrees 58 minutes 50 seconds on said North line, a distance of 193.50 feet to the point of beginning, containing an area of 4.55 acres more or less.

That I have prepared a plat of such tract of land to be known as Terhune Subdivision, containing Block 1, Lots 1 through 3, Block 2, Lots 1 through 15, part of Avenue "I", part of West Overland Drive and alleys. That the Blocks, Lots, Streets and alleys are well and accurately staked off and marked.

That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all dimensions are in feet and decimals. That all Block corners are marked with 3/4" x 36" iron rods and that all Lot corners are marked with 3/4" x 18" iron rods.

That the boundary of the subdivision is shown on the plat with a heavy solid line.
