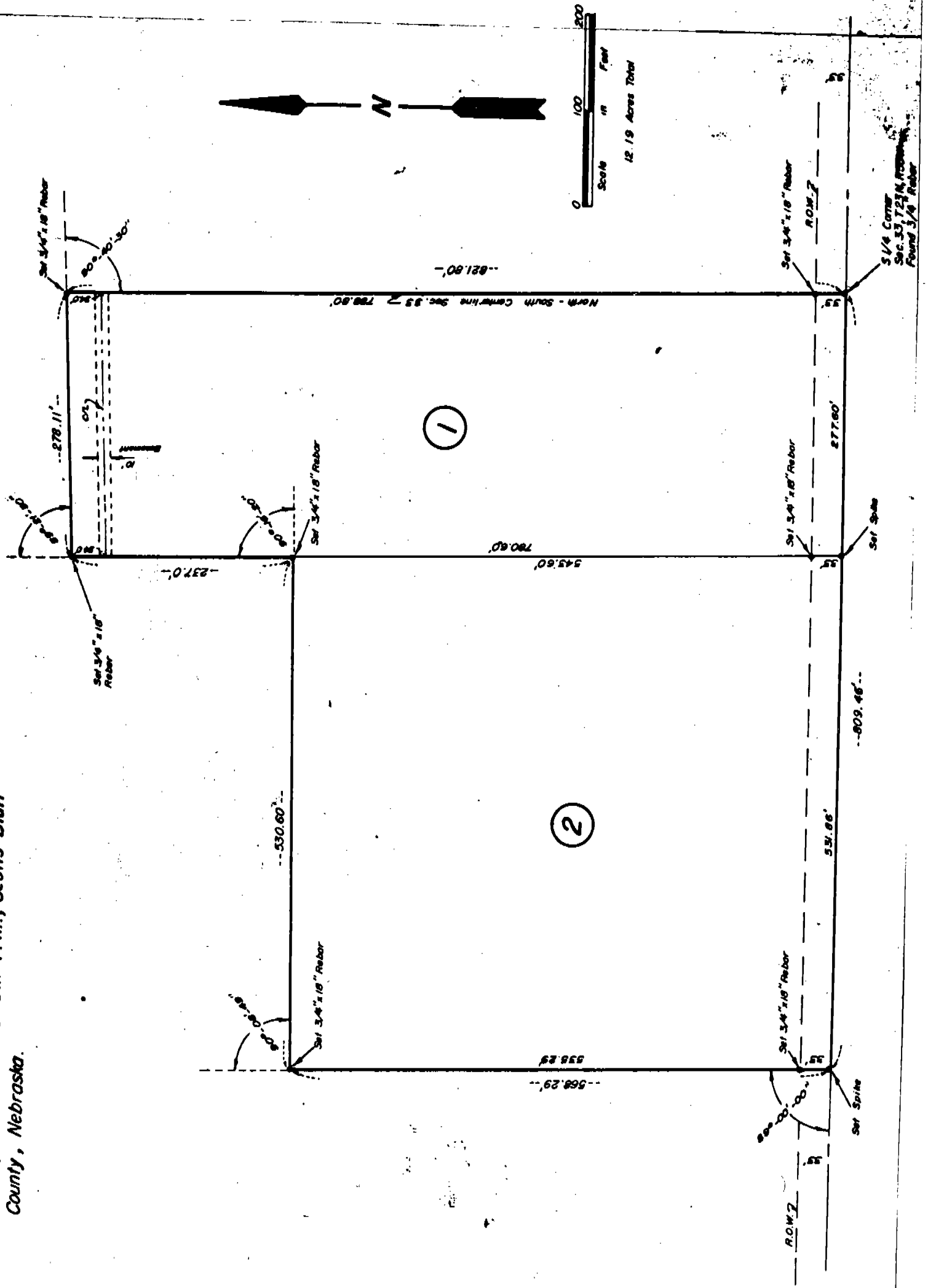

SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a Nebraska Registered Land Surveyor, hereby certify that a survey was made under my supervision of a tract of land situated in the Southwest Quarter of Section 33, Township 23 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, and a plat prepared of said tract to be known as Reinhardt's Addition, Blocks 1 and 2, the boundary of which is more particularly described as follows:

Beginning at the South Quarter corner of said Section 33; thence, westerly on the South line of said Section, a distance of 809.46 feet; thence, a deflection angle right of 89 degrees 00 minutes 00 seconds, a distance of 568.29 feet; thence, a deflection angle right of 90 degrees 08 minutes 49 seconds, a distance of 530.60 feet; thence, a deflection angle left of 90 degrees 16 minutes 20 seconds, a distance of 237.00 feet; thence, a deflection angle right of 89 degrees 21 minutes 50 seconds, a distance of 278.11 feet to the point of intersection with the North-South centerline of Section 33; thence, a deflection angle right of 90 degrees 40 minutes 30 seconds on said North-South centerline, a distance of 821.80 feet to the point of beginning, containing an area of 12.19 acres more or less.

That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all corners are marked as shown and that all dimensions are in feet and decimals and that each Block bears its own number. That the boundary of the survey is shown on the plat with a heavy solid line.

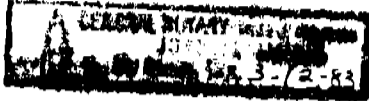

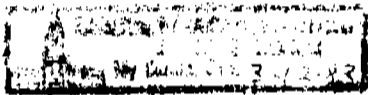

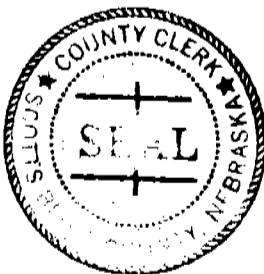

APPROVAL AND ACCEPTANCE

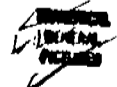
