LEGAL DESCRIPTION

-I. Charles A. McClanahan, a Registered Land Surveyor in the State of Nebraska, hereby certify that I have surveyed an irregular tract of land located in the Southwest Quarter (SW1) of Section Twenty-six (26), Township Twenty-three (23) North, Range Fifty-five (55) West of the 6th P.M., Scotts Bluff County, Nebraska, and more particularly described as follows:

With reference to the Southeast corner of said SW1; thence With reference to the Southeast corner of said SW1; thence North (an assumed bearing) along the East line of said SW1, for 50.21 feet to the point of beginning; thence continuing along the last described course, for 529.01 feet; thence South 89° 59' 09" West, for 525.40 feet; thence North 0° 00' 51" West, for 642.19 feet; thence South 89° 59' 09" West, for 928.19 feet; thence South 28° 33' 07" West, for 77.82 feet; thence South 30° 46' 40" East, for 141.40 feet; thence South 54° 33' 18" East, for 201.11 feet; thence South 36° 45' 55" East, for 1004.08 feet to a point 50 feet north of the South line of said SW1; thence South 84° 46' 04" East and parallel with the South line of said SW1 for 656.51 feet to and parallel with the South line of said SW2. for 656.51 feet to the point of beginning; said tract contains 20.03 acres, more or less.
