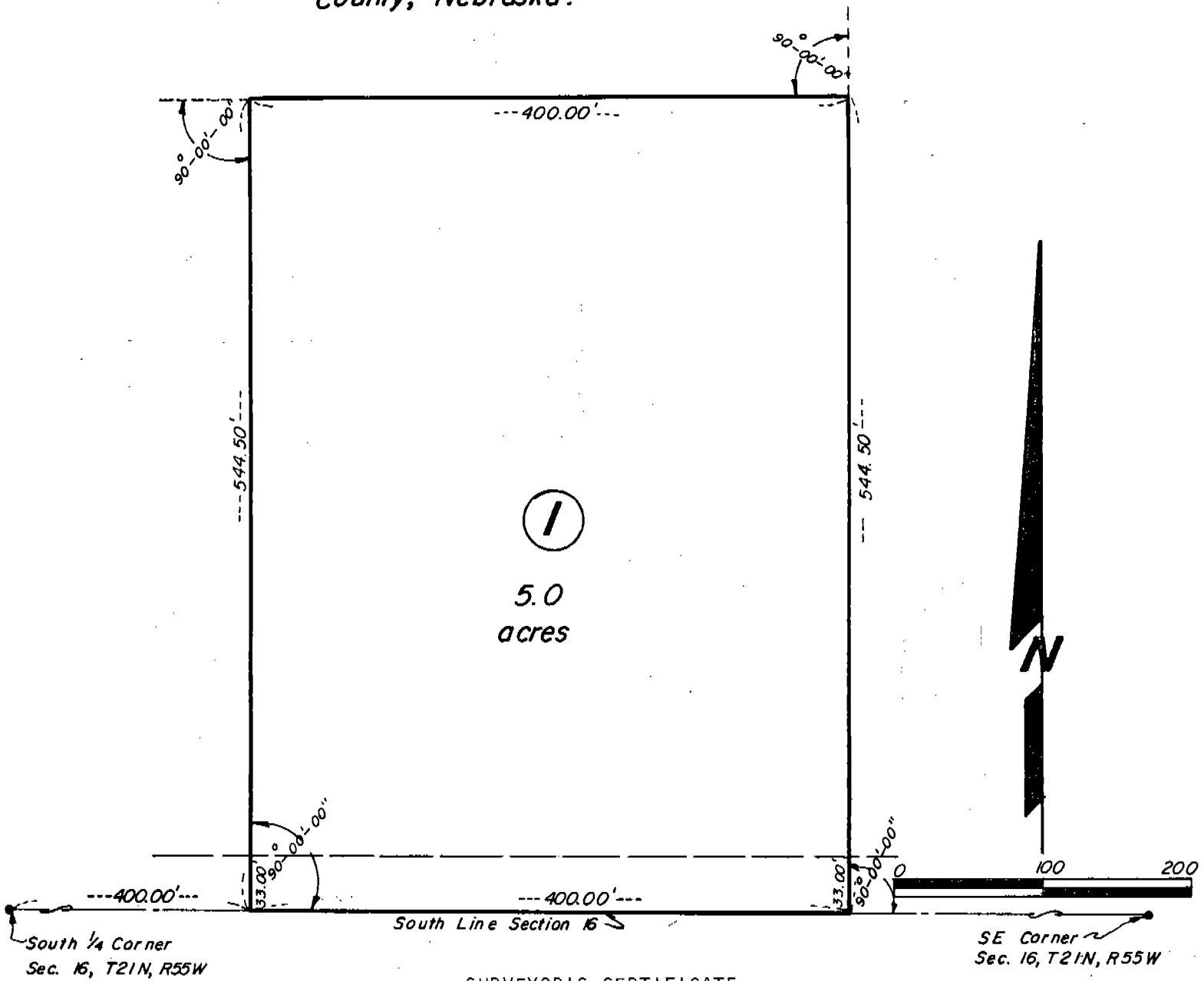

SURVEYOR'S CERTIFICATE

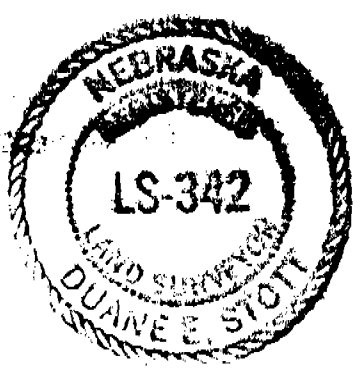
I, Duane E. Stott, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed a tract of land situated in the Southeast Quarter of Section 16, Township 21 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, to be known as SCHLEICHER SUBDIVISION, more particularly described as follows:

With reference to the South Quarter Corner of Section 16; thence, easterly on the South line of the Southeast Quarter of said Section, a distance of 400.00 feet to the TRUE POINT OF BEGINNING; thence, a deflection angle left of 90 degrees 00 minutes 00 seconds, a distance of 544.50 feet; thence, a deflection angle right of 90 degrees 00 minutes 00 seconds, a distance of 400.00 feet; thence, a deflection angle right of 90 degrees 00 minutes 00 seconds, a distance of 544.50 feet to the point of intersection with the South line of said Southeast Quarter; thence, a deflection angle right of 90 degrees 00 minutes on said South line, a distance of 400.00 feet to the point of beginning, containing an area of 5.00 acres more or less.

That the accompanying plat is a true delineation of such survey and subdivision drawn to a scale of 100 feet to the inch and that all corners are marked with 3/4" x 18" rebar or as shown.

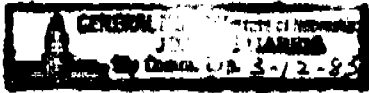

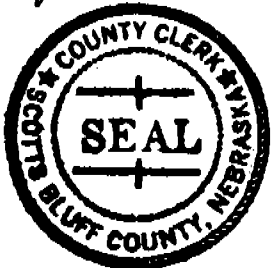
