

SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed a tract of land situated in the South Half of the Northwest Quarter of Section 11, Township 21 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, to be known as Wiley Addition, Block 1, the boundary of which is more particularly described as follows:

With reference to the Northeast corner of the South Half of the South Half of the Northwest Quarter of Section 11; thence, westerly on the North line of said South Half of the South Half of the Northwest Quarter of Section 11, a distance of 425.00 feet to the TRUE POINT OF BEGINNING; thence, continuing westerly on said North line, a distance of 489.00 feet; thence, a deflection angle left of 90 degrees 00 minutes, a distance of 133.00 feet; thence, a deflection angle left of 88 degrees 31 minutes, a distance of 490.45 feet; thence, a deflection angle left of 91 degrees 57 minutes, a distance of 146.00 feet to the point of beginning, containing an area of 1.57 acres more or less.
