



I, Duane E. Stott, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of WEBER SUBDIVISION REPLAT, a Replat of vacated Blocks 1 and 2 of Weber Subdivision, part of 17th Avenue and part of 7th Street, excluding Lot 1A of Block 1, situated in the Northeast Quarter of Section 25, Township 22 North, Range 55 West of the 6th P.M. Scotts Bluff County, Nebraska, the boundary of said Replat being more particularly described as follows:

Beginning at the point of intersection of the South Right of Way line of 9th Street and the West Right of Way line of 19th Avenue, thence southerly on the West Right of Way line of 19th Avenue, a distance of 734.30 feet, thence a deflection angle right of 890-07'-11", on a line parallel with and 33 feet North of the centerline of 7th Street, a distance of 1165.71 feet, thence a deflection angle right of $89^{\circ}-49^{\circ}-11^{\circ}$, on a line which is a prolongation of the West line of Lot 1A of Block 1, Weber Subdivision a distance of 600.89 feet to the Southwest corner of said Lot 1A, thence a deflection angle right of 90°-12'32", on the South line of said, Lot 1A, a distance of 103.00 feet to the Southeast corner of said Lot 1A, thence a deflection angle left of $90^{\circ}-12^{\circ}-32^{\circ}$, on the East line of said Lot 1A, a distance of 133.50 feet to the Northeast corner of said Lot 1A, thence a deflection angle right of 90° -12'-32" on the South Right of Way line of 9th Street, a distance of 1076.52 feet to the point of beginning containing an area of 19.45 acres more or less.

That the accompanying plat is a true delineation of such survey and replat drawn to a scale of 100 feet to the inch. That all Block corners are marked with $3/4^{\prime\prime}$ X $36^{\prime\prime}$ iron rods and that all dimensions are in feet and decimals. That each Block bears its own number and that the boundary of the replat is shown with a heavy solid line. That dashed lines are shown on the plat for orientation purposes only.
