

SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a Nebraska Registered Land Surveyor, hereby ceritfy that I have surveyed and prepared a plat of Block 1, R. C. Schlager Subdivision, situated in the North Half of the Northwest Quarter of Section 10, Township 23 North Range 57 West of the 6th P.M., Scotts Bluff County, Nebraska. The boundary of which is more particularly described as follows:

With reference to the Southwest Corner of the North Half of the Northwest Quarter of Section 10, thence easterly on the South line of said North Half, a distance of 621.20 feet to the TRUE POINT OF BEGINNING, thence continuing easterly on said South line, a distance of 228.76 feet, thence a deflection angle left of 90°-00'-00", a distance of 380.84 feet, thence a deflection angle left of 90° -00'-00'', a distance of 228.76 feet, thence a deflection angle left of 900-00'-00', *andistance of 380.84 feet to the Point of Beginning, containing an area of 2.00 acres more or less.

That the accompanying plat is a true delineation of such survey and subdivision drawn to a scale of 100 feet to the inch. That all corners are marked with 3/4" X 18" iron rods and that all dimensions are in feet and decimals. That the Block bears its own number and that the boundary is shown with a heavy solid line.
