

SURVEYOR'S CERTIFICATE

I, M.C. Schaff, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of Second Hidwest Subdivision, Block One (1), located in the City of Scottsbluff, Nebraska, situated in the Hortheast Quarter (NE1/4) of Section 26, Township 22 Horth, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, the boundary of such survey and subdivision being more particularly described as follows:

Beginning at a point on the west line of Broadway, as previously platted in the City of Scottsbluff, located 100.0 feet north of the north line of the South Beltline Highway, as previously platted in the City of Scottsbluff; thence northerly on the said west line of Broadway, a distance of 97.70 feet; thence westerly on a line parallel with the said north line of the South Beltline Highway, a distance of 170.00 feet; thence southerly on a line parallel with the said west line of Broadway, a distance of 197.70 feet to the said north line of the South Beltline Highway; thence easterly on the said north line of the South Beltline Highway, a distance of 20.00 feet; thence northerly on a line parallel with the said west line of Broadway, a distance of 100.00 feet; thence easterly on a line parallel with the said north line of the South Beltline Highway, a distance of 150.00 feet to the point of beginning, containing an area of 0.43 acres, more or less.

That the above described tract contains Block 1, platted as part of this subdivision. That the accompanying plat is a true delineation of such survey and subdivision drawn to a scale of 100 feet to the inch. That all corners are marked with 3/4" x 18" iron rods. That all dimensions are in feet and decimals. That the boundary of the subdivision is shown on the plat with a heavy solid line. That the dashed lines shown on the plat are for orientation purposes only.


