
## LOT IA, BLOCK I, SEIVER SECOND SUBDIVISION



A Replat of Lot I, Block I, Seiver Second Subdivision and part of the NE 4 Section 16, Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska.



## SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a Replat of , vacated Lot 1, Block 1, Seiver Second Subdivision along with adjacent unplatted land, all being situated in the Northeast Quarter of Section 16, Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska. That said Replatted land will be known as Lot la, Block 1, Seiver Second Subdivision, the boundary of which is more particularly described as follows:

With reference to the Northeast corner of section 16, thence southerly on the East line of said section, a distance of 1287.30 feet, thence a deflection angle right of  $88^{\circ}$ -23'-51", a distance of 33.00 feet to the Southeast corner of Lot 2, Block 1, Seiver Second Subdivision and the TRUE POINT OF BEGINNING, thence continuing westerly on the South line of said Lot 2 and its westerly extension, a distance of 462.50 feet to the point of intersection with the northeasterly Right of Way line of U.S. Highway #26, thence a deflection angle left of  $134^{\circ}-33'-27"$ , on said northeasterly Right of Way line, a distance of 641.02 feet to the point of intersection with the West Right of Way line of Avenue Z, thence a deflection angle left of  $133^{\circ}$ -48'-20" on said West Right of Way line, a distance of 457.41 feet to the point of beginning, containing an area of 2.42 acres more or less.

That the accompanying plat is a true delineation of such survey and Replat drawn to a scale of 100 feet to the inch and that all corners are marked as shown. That all dimensions are in feet and decimals and that the lot bears its own number. The boundary of the subdivision is shown with a heavy solid line with dashed lines being shown for orientation purposes.
