### SURVEYOR'S CERTIFICATE

I, Robert J. Zumbahlen, do hereby certify that I have surveyed and platted a tract of land in the Northwest Quarter of the Northeast Quarter of Section 14, Township 22 North, Range 55 West of the 6th Principal Meridian, Scotts Bluff County, Nebraska, more particularly described as follows:

Beginning at the intersection of the south line of 42nd Street and the east line of Avenue B in the City of Scottsbluff; thence North 89° 41'00" East along the south line of said 42nd Street, for 933.36 feet; thence South along a line parallel with the east line of said Avenue B, for 1654.36 feet; thence South 89° 39'00" West, for 933.36 feet to a point on the east line of said Avenue B, 60.00 feet north of the northwest corner of Block One (1), Ross Third Subdivision; thence North along the east line of said Avenue B, for 1654.90 feet to the Point of Beginning and containing an area of 35.45 acres, more or less.

That the tract of land contains 21.56 acres, more or less: that the accompanying plat represents a correct delineation of such survey drawn to a scale of 100 feet to the inch: that 5/8" x 30" rebar were set at all corners not shown as found corners: that all dimensions are in feet and decimals of a foot; and that all bearings are based on the bearing of North along the west line of Rugger Park Addition and Rugger Park Second Addition to the City of Scottsbluff, Nebraska, from a survey by Charles A. McClanahan, dated August 14th, 1978.
