

SURVEYOR'S CERTIFICATE

i, M. C. Schaff, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of UPLAND ADDITION, Block 1, an addition situated in the Southwest Quarter of Section 34, Township 23 North, Range 58 West of the 6th P. M., Scotts Bluff County, Nebraska, more particularly described as follows:

With reference to the South Quarter Corner of said Section 34, thence North, on the North—South Centerline of said Section 34, a distance of 1711.85 feet to the Point of Beginning; thence continuing on the last described course, a distance of 101.10 feet; thence a deflection angle left of 98 degrees 28 minutes 29 seconds, a distance of 1170.00 feet; thence a deflection angle left of 90 degrees 00 minutes 00 seconds, a distance of 100.00 feet to the North Right of Way of the Union Pacific Railroad; thence a deflection angle left of 90 degrees 00 minutes 00 seconds, on said Right of Way, a distance of 1155.10 feet to the Point of Beginning, containing an area of 2.67 acres, more or less.

That the accompanying plat is a true delineation of said survey and addition drawn to a scale of 100 feet to the inch and that all dimensions are in feet and decimals. That all block and lot corners are marked with 5/8 inch by 30 inch iron rods. That each lot and block bears its own number. That the dashed lines shown on the plat are for orientation purposes only and that the boundary of the addition is shown on the plat with a heavy solid line.


