SURVEYOR'S CERTIFICATE

I, M. C. Schaff, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of Replat of Lot 3, UPLAND ADDITION, an addition situated in the Southeast Quarter of Section 35, Township 22 North, Range 55 West of the 6th P. M., in the City of Gering, Scotts Bluff County, Nebraska, more particularly described as follows:

With reference to a point which is the Northwest Corner of the Southeast Quarter of the Southeast Quarter, thence South on the West Line of said Southeast Quarter of the Southeast Quarter, a distance of 648.00 feet to the Point of Beginning; thence continuing on the last described course, a distance of 363.55 feet; thence a deflection angle left of 90 degrees 00 minutes 00 seconds, a distance of 159.91 feet; thence a deflection angle left of 100 degrees 34 minutes 29 seconds to the long chord of a curve to the right, said curve having a radius of 201.47 feet and a central angle of 18 degrees 29 minutes 36 seconds; thence Northwesterly, along the arc of said curve, a distance of 65.03 feet, thence continuing Northerly, tangent to said curve, a distance of 299.95 feet; thence a deflection angle left of 88 degrees 39 minutes 42 seconds, a distance of 140.96 feet to the Point of Beginning, containing an area of 1.19 acres, more or less.

That the accompanying plat is a true delineation of said survey and plat drawn to a scale of 100 feet to the inch.
