

SURVEYOR'S CERTIFICATE

I, Kelly A. Beatty, a Nebraska Registered Land Surveyor, hereby certify I have surveyed and prepared a plat of Block One, Schutte Subdivision, situated in the Northwest Quarter of the Southeast Quarter of Section 11, Township 21 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows:

Commencing at the Northwest corner of the Northwest Quarter of the Southeast Quarter of Section 11, thence southerly on the west line of the Northwest Quarter of the Northesst Quarter of Section 11, on an assumed bearing of \$00°00'00"E, a distance of 1225.30 feet, as measured, to the point of intersection with the north line of a Tract of Land described in Deed Book 16, page 214, Scotts Bluff County Register of Deeds Office, thence bearing Seg°41'27"E, on the north line of said referenced Tract of Land, and on a line 100 feet north of and parallel with the south line of the Northwest Quarter of the Southeast Quarter of Section 11, a distance of 84.07 feet, to the Point of Beginning, said point also being the southwest corner of a Tract of Land as referenced in Inst. Book 2003, page 6903, thence continuing easterly on said north line of said first referenced Tract of Land in Deed Book 16, page 214, and on a line being 100 feet north of and parallel with the south line of the Northwest Quarter of the Southeast Quarter of Section 11, a distance of 1214.00 feet, as measured, to the point of intersection with the west line of a Tract of Land referenced in Deed Book 16, page 214, said west line being 50 feet west of the east line of the Northwest Quarter of the Southeast Quarter of Section 11, as measured perpendicular to said east line, thence bearing N00°06'05"W, on the west line of said referenced Tract of Land in Deed Book 16, page 214, and on a line being 50 feet west of and parallel with the east line of the Northwest Quarter of the Southeast Quarter of Section 11, a distance of 562.70 feet, as measured, to the point of intersection with the south right of way line of State Highway 71, as described in Instrument Book 2003, page 4737 (Tract 13 - page 1), thence bearing S71°42'57"W, on the south right of way line of State Highway 71, a distance of 1236.75 feet, as measured, to the point of curvature of a curve to the left, said curve having a central angle of 30°36'16", a radius of 131.22 feet, a chord bearing of \$34°38'43"W, and a chord length of 69.34 feet, thence southwesterly on the arc of said curve, and south right of way line of State Highway 71, a distance of 70.17 feet, to the point of tengency, thence bearing S00°22'48"E, on the southerly right of way of State Highway 71, a distance of 111.10 feet, as measured, to the Point of Beginning, containing an area of 19.00 acres, more or less

That the accompanying plat is a true delineation of said survey drawn to a scale of 300 feet to the inch. That all dimensions are in feet and decimals. That each lot and block has its own number. That the boundary of the plat is shown with a heavy solid line with dashed lines being for orientation purposes only. That all corners found or set are marked as shown.
