



# LICENSE AGREEMENT

This License Agreement ("Agreement") is entered into this 5th day of October, 2009, by and between the City of Scottsbluff, Nebraska, a municipal corporation ("Licensor"), and Donald A. Krug a single person ("Licensee")

In consideration of the mutual promises contained in this Agreement, the parties agree as follows:

#### 1. Grant of license:

Licensor now grants a license to Licensee to occupy and use, subject to all of the terms and conditions of this Agreement, the following described property:

A part of the Licensor's right-of-way for Avenue X and 17<sup>th</sup> Street, located on the north and northwest property lines of Tract 25A, Amended Plat of R.S. Hunts Tract in the City of Scottsbluff, Scotts Bluff County, Nebraska (the "licensed property").

# 2. <u>Limitation to described purpose:</u>

The licensed property constitutes part of Licensor's right-of-way occupied by Licensee's building on the west and north side of his property line. Licensee agrees to use the licensed property solely for storage purposes. Licensor grants the Licensee the right for the building, currently being used as storage, to continue to encroach into the Licensee's street right-of-way for Avenue X on the west and 17<sup>th</sup> Street on the north. This right of encroachment shall continue until this Agreement is terminated.

## 3. Termination:

- a. The Licensor may terminate this Agreement at any time, by giving written notice to the Licensee, specifying the date of termination. Such notice shall be given not less than thirty days prior to the date specified in such notice for the date of termination.
- b. Should the storage buildings currently located on the licensed property, and encroaching on the Licensor's right-of-way for Avenue X on the west and 17<sup>th</sup> Street on the north, or any essential part of the buildings, be totally destroyed by fire or other casualty, this Agreement shall immediately terminate. Licensee shall not have the right to rebuild any buildings on the licensed property which would encroach on Licensor's right-of-way to Avenue X on the west side of the property or 17<sup>th</sup> Street on the north side of the Licensee's property.

### 4. Notices:

Any notice provided for or concerning this Agreement shall be in writing and shall be sufficiently given when sent by United States First Class Postal Service delivery to the addresses of the parties as listed below:

#### 5. Assignment of rights:

The rights of each party under this Agreement are personal to that party and may not be assigned or transferred to any other person, firm, corporation or other entity. The right to occupy the right-of-way may be terminated at any time by the Licensor. Any of Licensee's heirs or assigns shall not have the right to rely on the placement of the storage building within the Licensor's right-of-way for Avenue X and 17<sup>th</sup> Street.
