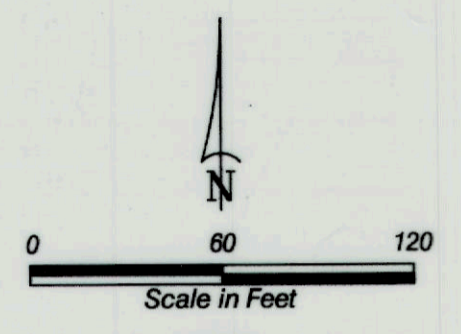

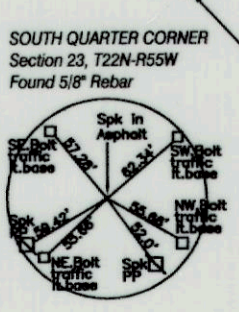

 - 3 The exterior boundary of Lots 1 - 4, Block 3, Tri-State Addition, (Except for the 20' Vacated Alley) is generally described in a Deed recorded in Book 207, Page 442, dated 7-28-95, from Burlington Northern Railroad Company to Clarence D. Hergert.



I, Kelly A. Beatty, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of Lots 1 through 4, Block 3, Tri-State Addition, in the City of Scottsbluff, Scotts Bluff County, Nebraska, a Plat of vacated 20' Alley and unplatted lands situated in the Southwest Quarter of the Southeast Quarter of Section 23, Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows:

Commencing at the South Quarter Corner of Section 23, thence northerly on the west line of the Southeast Quarter of Section 23, on an assumed bearing of $N01^{\circ}50'30''E$, a distance of 744.28 feet, to a point being 150.00 feet southwest of the centerline of the BNSF Main Track, as measured perpendicular to said centerline, thence bearing $S44^{\circ}20'15''E$, on a line parallel with the centerline of said track, a distance of 17.59 feet, to the Point of Beginning, thence bearing $N45^{\circ}39'45''E$, a distance of 25.00 feet, to a point being 30.00 feet east of the west line of the Southeast Quarter of Section 23, as measured perpendicular to said west line, thence bearing $N01^{\circ}50'30''E$, on a line 30.00 feet east of and parallel with the west line of the southeast Quarter of Section 23, a distance of 128.40 feet, to a point being 9.00 feet south of the centerline of Spur Track No. 20, as measured perpendicular to said centerline, said point being on a non-tangent curve to the right, said curve having a central angle of $15^{\circ}21'58''$, a radius of 694.14 feet, as measured, a chord length of 185.60 feet, and a chord bearing of $S27^{\circ}51'42''E$, thence southeasterly on the arc of said curve, and on a line being 9.00 feet southwesterly and parallel with the centerline of said Spur Track No. 20, a distance of 186.16 feet, to a point being 85.00 feet southwest of the centerline of the BNSF Main Track, as measured perpendicular to said centerline of main track, thence bearing $S44^{\circ}20'15''E$, on a line being 85.00 feet southwesterly of and parallel with said main track, a distance of 867.94 feet, as measured, to the point of intersection with the westerly right of way of Broadway, said right of way line being the northerly extension of the east line of Lots 1A and 2A, Block 1, Southside Addition to the City of Scottsbluff, Nebraska, thence bearing $S02^{\circ}07'39''W$, on said right of way line, a distance of 89.66 feet, to a point being 150.00 feet southwesterly of the centerline of the BNSF Main Track, as measured perpendicular to said centerline, thence bearing $N44^{\circ}20'15''W$, on a line 150.00 feet southwesterly of and parallel with the centerline of the BNSF Main Track, a distance of 796.59 feet, to the point of intersection with the west right of way line of a 20 foot wide alley, as platted, thence bearing $S01^{\circ}50'30''W$, on said west right of way line of alley, a distance of 27.72 feet, to a point being 170.00 feet southwesterly of the centerline of the BNSF main track, as measured perpendicular to said track, thence bearing $N44^{\circ}20'15''W$, on a line being 170.00 feet southwesterly of and parallel with said centerline of main track, a distance of 194.04 feet, to a point being 33.00 feet east of the west line of the Southeast Quarter of Section 23, as measured perpendicular to said west line, thence bearing $N01^{\circ}50'30''E$, on a line being 33.00 feet east of and parallel with the west line of the Southeast Quarter of Section 23, a distance of 27.72 feet, to a point being 150.00 feet southwesterly of the centerline of BNSF main track, as measured perpendicular to said centerline of main track, thence bearing $N44^{\circ}20'15''W$, on a line 150.00 feet southwesterly of and parallel with said centerline of main track, a distance of 28.15 feet, to the point of Beginning, containing an area of 1.68 acres, more or less.

That the accompanying plat is a true delineation of such survey drawn to a scale of 60 feet to the inch. That all dimensions are in feet and decimals. That each lot and block has its own number and that the boundary of the plat is shown with a heavy solid line with dashed lines being for orientation purposes only. That all corners found or set are marked as shown.


OWNER'S STATEMENT



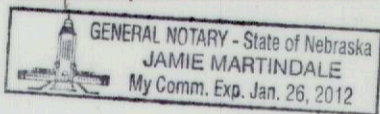
